## MAYOR/COUNCILMEMBER COMMUNICATIONS

Councilmember Ontiveros-Cole thanked staff for providing residents with sandbags to prepare for Sunday's storm. She attended an event hosted by Project Resilience in collaboration with local churches. Lastly, she requested Chief Ellis check out a vacant building on Mission and Linden.

Councilmember Preciado thanked staff for helping residents prepare for Hurricane Hillary. He attended the celebration for the opening anniversary of Delicious Freedom USA in downtown Pomona.

Councilmember Torres gave thanks to staff for handing out sandbags. He also expressed satisfaction with the updated look of the Council Chambers.

Councilmember Garcia gave thanks to the Public Works Dept. and Water Dept. staff for helping residents prepare for Hurricane Hillary. She also gave thanks to the Library and Community Services staff for the amazing summer programming they provided to residents. She was the closing conference speaker at the Laspa Center at Scripps College.

Vice Mayor Nolte expressed satisfaction with the updated look of the Council Chambers and thanked staff for their help in being prepared for the storm. He gave thanks to Athens for their donation of a police dog to the police department. He attended an event hosted by the Electrical Workers Union in Commerce, and was impressed by their training facilities. He also attended a Community Wealth Building Workshop hosted by United Way of Los Angeles.

Councilmember Lustro thanked staff that was on duty during the storm, and expressed satisfaction with returning to Council Chambers for City Council meetings.

Mayor Sandoval gave thanks to City Manager Makshanoff and the staff that were a part of renovating the Council Chambers. ## **CITY MANAGER COMMUNICATIONS**

He also advised staff is working on updating the pumping system at the Reservoir St. underpass to avoid future closures of it during storms.
