## 2. Discussion on Community Awareness Day Event and Approval of Dates for Event

Commissioner Brooks gave comments about his experiences with attending Area Commander meetings and recommended keeping the reports simple.

Chair Russell expressed support for adding a summary to each community meeting.

Commissioner Gibani recommended attending community meetings to have first-hand experiences.

Commissioners continued to discuss and ask questions about Commissioner Yanez's recommendations.

Chair Russell recommended forming an ad-hoc committee to better establish the purpose of the recommended additional data collection.

Commission Secretary Robles gave an update on the status of the Police Oversight Commission vacancy.

City Clerk Butler wished everyone happy holidays.

Commissioner Yanez advised he had completed the ride-along with the Pomona Police Department and gave thanks to Officer Ruiz.

Chair Russell invited folks to attend the Day of Prayer and Empowerment at Fountain Church.

**ADJOURNMENT**


Chair Russell adjourned the regular meeting at 7:44 p.m. on December 9, 2025.
