

RESOLUTION NO. 2023-107

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
POMONA, CALIFORNIA, AMENDING THE FISCAL YEAR 2022-23  
OPERATING BUDGET TO REFLECT THE IMPLEMENTATION OF A  
TWO AND ONE HALF (2.5%) GENERAL SALARY INCREASE**

**WHEREAS**, the City Council adopted the FY 2022-23 Operating Budget, Housing Authority Budget, and the Five-Year Capital Improvement Program on June 6, 2022 and all appropriations for departments or major organizational units within the General Fund and all operating funds were approved;

**WHEREAS**, frequent fiscal review is prudent to ensure that the City maintains a healthy financial structure;

**WHEREAS**, the City Council approved amendments to the fiscal year 2022-23 Operating Budget on August 15, 2022, October 3, 2022, October 17, 2022, November 21, 2022, December 19, 2022, January 23, 2023, and March 20, 2023; and

**WHEREAS**, the City Council wishes to further amend the Operating Budget appropriations to reflect a two and one-half percent (2.5%) general salary increase retroactively effective October 9, 2022 for full-time classifications and January 15, 2023 for part-time classifications.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona, California, as follows:

**SECTION 1.** Amending the Fiscal Year 2022-2023 Operating Budget by increasing appropriations in the amount of \$1.4M, as reflected in Exhibit A, which includes \$979k in General Fund appropriations to implement a 2.5% general salary increase effective October 9, 2022 for full-time classifications and January 15, 2023 for part-time classifications.

**SECTION 2.** The actions approved by this resolution shall become effective immediately upon its approval.

**SECTION 3.** The City Clerk shall certify to the passage and adoption of this resolution, and it shall thereupon be in full force and effect.
