

RESOLUTION NO. 2023-145

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ACCEPTING THE STATE OF CALIFORNIA OFFICE OF TRAFFIC SAFETY PEDESTRIAN AND BICYCLE SAFETY GRANT IN THE AMOUNT OF \$43,787 AND AMENDING FY 2023-24 OPERATING BUDGET TO INCREASE REVENUE ESTIMATES AND APPROPRIATIONS BY \$43,787

WHEREAS, the Pomona Police Department has conducted numerous enforcement and education programs to ensure compliance with vehicle laws; and

WHEREAS, the Police Department has been awarded a State of California Office of Traffic Safety (OTS) Pedestrian and Bicycle Safety Grant for a total award of \$43,787;

WHEREAS, the Pedestrian and Bicycle Safety Grant has been awarded to fund the Pomona Police Department's efforts to reduce the number of persons injured and killed in pedestrian and bicycle incidents beginning October 1, 2023 through September 30, 2024;

WHEREAS, the authority to accept the Pedestrian and Bicycle Safety Program Grant and amend the current revenue and operating budgets to appropriate the OTS grant funds to be received is vested with City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby accepts the State of California OTS Pedestrian and Bicycle Safety Program Grant and agrees to the terms and conditions of the Grant Agreement.

SECTION 2. That the City Council hereby amends the FY 2023-24 Police Department Grants Fund budget revenue estimate by \$43,787 (215-2014-40875-58783), with a corresponding \$43,787 appropriation (215-2014-XXXXX-58783).

SECTION 3. That the City Manager, or designee, is hereby authorized to execute any and all agreements on behalf of the City, in substantially the form submitted, subject to review and approval by the City Attorney.

SECTION 4. That City Clerk shall attest to and certify to the passage and adoption of this resolution and it shall be effective immediately upon its approval.
