RESOLUTION NO. 2024-48

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING THE FY 2024-2025 ANNUAL ACTION PLAN WITH PROPOSED FUNDING FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG), HOME INVESTMENT PARTNERSHIPS (HOME) AND EMERGENCY SOLUTIONS GRANT (ESG) PROGRAMS

- **WHEREAS,** the City of Pomona, pursuant to Federal regulations, has prepared, circulated and solicited public input and conducted a public hearing within the City of Pomona, located in the United States, on the FY 2024-2025 Annual Action Plan with proposed funding;
- **WHEREAS,** the City of Pomona, after due consideration and review, has complied with the necessary Federal, State and local regulations and requirements; and
- **WHEREAS**, the approvals herein are preliminary for inclusion in the Draft Annual Action Plan; final approvals will be adopted at the conclusion of the 30-day public comment period.
- **NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Pomona, as follows:
- **SECTION 1.** That the City Council approves the estimated recommended funding amounts for projects funded under the Federal Entitlement Programs of CDBG and ESG, as indicated in Exhibits A and B.
- <u>SECTION</u> 2. That the City Council hereby authorizes adding the estimated recommended funding amounts, reflected in Exhibits A and B, to the Annual Action Plan to be submitted to the Department of Housing and Urban Development (HUD) for FY 2024-2025 for the Federal Entitlement Programs.
- **SECTION 3.** That the City Council hereby approves the inclusion of funding recommendations under the following Federal Entitlement Programs and of the Home Investment Partnership (HOME) Program in the amount of \$723,880 into the Consolidated Plan and Annual Action Plan and appropriation of the same in the FY 2024-2025 City Operating Budget.
- **SECTION 4**. That the City Council authorizes the City Manager, or their designee, to execute all documents related to the FY 2024-2025 CDBG, HOME, and ESG Entitlement Programs.
- **SECTION 5.** That the City Clerk shall attest and certify to the passage of this resolution and it shall thereupon take effect and be in full force.
