

RESOLUTION NO. 2023-112

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING A SIDE LETTER AGREEMENT TO THE 2021-2023 MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF POMONA AND THE POMONA PART-TIME GENERAL UNIT TEAMSTERS LOCAL 1932 (PTG) IMPLEMENTING A 2.5% SALARY INCREASE

WHEREAS, the City Council has the authority to create, classify and assign salary scales/ranges for all City of Pomona classifications;

WHEREAS, on October 18, 2021, the City Council adopted Resolution No. 2021-143 adopting the 2021-2023 Memorandum of Understanding (MOU) between the City of Pomona and the Pomona Part-Time General Unit Teamsters Local 1932 (PTG);

WHEREAS, the 2021-2023 MOU Article V. Section A. Salary, includes provisions of negotiated salary increases; and

WHEREAS, the City Council authorizes the City Manager to negotiate and enter into a Side Letter Agreement with PTG to amend Article V. Section A. Salary to add a two and one-half percent (2.5%) salary increase retroactive to January 15, 2023.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona, California as follows:

SECTION 1. That the City Council hereby authorizes the City Manager to negotiate and enter into a Side Letter Agreement in “Exhibit A” that provides a two and one-half percent (2.5%) salary increase retroactive to January 15, 2023.

SECTION 2. Approve the amendment to the 2021-23 PTG MOU regarding a two and one-half percent salary increase retroactive to January 15, 2023.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this resolution, and it shall become effective immediately upon its adoption.

**Side Letter Agreement to the
2021-2023 Memorandum of Understanding
between
The City of Pomona and the Pomona Part-Time General Unit Teamsters Local
1932 (PTG)**

This Side-Letter of Agreement is entered into by and between the City of Pomona and the Pomona Part-Time General Unit Teamsters Local 1932 (PTG) and is effective upon the execution of both parties and adoption by the City Council.

WHEREAS, the City realized a budget surplus in fiscal year 2022-2023; and

WHEREAS, the City extended and the Union accepted a two and one-half percent (2.5%) salary increase. This action by the City Council recognizes the dedication of all current PTG employees as negotiations for a successor Memorandum of Understanding (MOU) begins; and

WHEREAS, the City Council approved amending the 2021-23 PTG MOU, Article V. Section A. Salary to add a 2.5% salary increase retroactive to January 15, 2023; and

WHEREAS, the City and PTG met and conferred regarding this increase;

Now therefore the parties agree as follows:

1. That the salary ranges for all classifications in PTG and employee salary rates shall be increased by 2.5% retroactive to January 15, 2023;
2. That nothing in this agreement shall be considered precedent-setting or establish a past practice;
3. All other terms and conditions of the current MOU between the parties shall remain in effect.
