SUBJECT: MANDATED BIENNIAL REVIEW OF THE CITY'S CONFLICT OF

INTEREST CODE

RECOMMENDATION:

It is recommended that the City Council direct staff to review the City's current Conflict of Interest Code.

EXECUTIVE SUMMARY:

The Political Reform Act (Government Code Section 87306.5) requires every local government agency to review its Conflict of Interest Code ("Code") every even-numbered year (biennially) and determine whether the Code needs to be amended. This process begins with the City Council directing staff to review the current Conflict of Interest Code for any updates and amendments.

FISCAL IMPACT:

There is no fiscal impact to this action.

DISCUSSION:

Government Code Section 87306.5 mandates that local government agencies review its Conflict of Interest Code biennially. The City Council is the code reviewing body for the City of Pomona, Pomona Housing Authority, and the Pomona Successor Agency to the former Redevelopment Agency. The City Council must notify staff to review its Code. No later than October 1st of each even-numbered year, staff must submit to the City Council a report indicating whether or not an amendment is necessary.

City staff will begin reviewing each City position to determine whether it should be included on the list of designated Statement of Economic Interests (Form 700) filers. By October 1, 2024, a report will advise the City Council whether or not amendments need to be made to the existing Code. If amendments are necessary, the revised Code will be placed on a City Council agenda for review no later than December 2, 2024. A City's amended code is not effective until it has been approved by the City Council.
