Staff Update

Staff recommends the Cultural Arts Commission review the updated project budget and renderings for the Palomares Park Project Refresh Group.

Background

At the Cultural Arts Commission meeting on May 22nd, 2023, Palomares Park Project Refresh Group ("Artists") brought a proposal to amend their contract of completed projects with an additional project on the Lona Lawson west facing exterior wall. The Commission approved this additional project with the condition that the Artists worked with Staff to paint more of the wall. The Commission also approved a budget change of \$25/sqft, increasing their proposed budget from \$16,236 to \$18,450.

On August 23rd, 2023, the Artists presented staff with a new budget and updated rendering that would require the Commission to review. The Artists stated that - "...upon further research and locking down final details, we realized that the first proposed budget was inadequate for the new adjacent walls that were requested to be added as well. The \$18,450 reflected only the large wall. This new budget reflects all the other adjacent walls combined, along with the large wall. These additional walls were requested to be added after we made the calculations for the first proposed budget. We have also adjusted the material pricing due to inflation (pricing which has changed from when first proposed to now). Therefore, this new budget more accurately reflects our expenses."

Project Description

May 22nd, 2023 - The Artists original proposal for the Lona Lawson west facing exterior wall was proposed as below at 738 sq/ft at \$22 per square footage, totaling their budget at \$16,236.00.
