A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2022-23 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY UNAPPROPRIATING \$56,142 OF UNEXPENDED EQUIPMENT MAINTENANCE FUNDS FROM "FLEET SHOP VEHICLE HOIST REPLACEMENTS," PROJECT NO. 428-2590-XXXXX-71056, CREATING A NEW PROJECT "SWAMP COOLERS REPLACEMENT – FLEET SHOP," PROJECT NO. 428-2590-XXXXX-71087, AND APPROPRIATING \$56,142 OF EQUIPMENT MAINTENCE FUNDS AND \$27,238 OF WATER FUND RESERVE TO THE NEW PROJECT

WHEREAS, the City Council desires to create a new project, "Swamp Coolers Replacement – Fleet Shop," Project No. 428-2590-XXXXX-71087; and

WHEREAS, the City Council desires to fully fund "Swamp Coolers Replacement – Fleet Shop" (Project) by unappropriating \$56,142 of Equipment Maintenance Funds from "Fleet Shop Vehicle Hoist Replacement," Project No. 428-2590-XXXXX-71056 and appropriating \$56,142 of Equipment Maintenance Funds and \$27,238 of Water Fund Reserve to the new Project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council amends the FY 2022-23 Capital Improvement Program (CIP) budget by creating a new project, "Swamp Coolers Replacement – Fleet Shop," Project No. 428-2590-XXXXX-71087.

SECTION 2. That the City Council amends the FY 2022-23 CIP Budget by unappropriating \$56,142 of unexpended Equipment Maintenance Funds from "Fleet Shop Vehicle Hoist Replacements," Project No. 428-2590-XXXXX-71056 (428-2590-66196-71056, 428-2590-80723-71056) and appropriating these funds to "Swamp Coolers Replacement – Fleet Shop," Project No. 428-2590-XXXXX-71087 (428-2590-66196-71087, 428-2590-80723-71087).

SECTION 2. That the City Council amends the FY 2022-23 CIP Budget by appropriating \$27,238 from Water Fund Balance to the new Project (428-2590-66196-71087, 571-2590-89987-71087, and 428-2590-80702-71087.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
