

RESOLUTION NO. 2026-54

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING A TAKEOVER AGREEMENT AND BILL OF SALE FOR THE TRANSFER OF EXISTING AND PROPOSED SEWER FORCE MAINS.

WHEREAS, the County Sanitation Districts Nos. 2 and 21 of Los Angeles County, county sanitation districts organized and existing under the provisions of the County Sanitation District Act, Health & Safety Code §4700 *et seq.* (collectively, the “Districts” and individually, “District 2” and District 21”, respectively) own and operate regional sewer systems, pumping plants, treatment plants, outfalls, and incidental sanitation works in the northeast portion of Los Angeles County.

WHEREAS, On July 27, 1966, the City and District No. 21 entered into an agreement for the purchase and sale of the recycled water produced at the Pomona Water Reclamation Plant.

WHEREAS, On March 3, 1986, the City Council adopted Resolution No. 86-51 authorizing an agreement with District No. 2 for the temporary operation and maintenance of the City’s four sewage pumping plants for the purpose of evaluating the feasibility of permanent District ownership of the pumping plants.

WHEREAS, On December 18, 2012, City Council adopted Resolution 2012-162 authorizing a takeover agreement with the District for the permanent transfer of ownership, operation, and maintenance of pumping plants number 1, 2, 3, and 4, along with the sewer force mains associated with pumping plant 4.

WHEREAS, District No. 2 is prepared to assume ownership and maintenance of the existing and proposed force mains associated with pumping plants number 2 and 3 under the terms and conditions set forth in this additional Takeover Agreement.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby approves the Takeover Agreement between the City and District No. 2 for the transfer of the Existing and Proposed Force Mains associated with Pumping Plants No. 2 and 3, in substantially the form submitted and attached hereto as Attachment No. 1.

SECTION 2. That the City Council hereby approves the Bill of Sale between the City and District No. 2, provided as Exhibit C to the Takeover Agreement.

SECTION 3. The City Manager is hereby authorized to execute the Takeover Agreement and Bill of Sale on behalf of the City.

SECTION 3. That the City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
