### **DISCUSSION:**

## **●**Eight-Month Vice-Mayor Selection Cycle

Pursuant to Section 2-41(a) of the Pomona City Code (PCC), the City Council shall select one of its members as Vice-Mayor every eight months. Accordingly, it is recommended that the City Council adopt the attached Resolution No. 2025-120 (Attachment 1) establishing the order of appointment as Districts 4, 6, 1, 2, 3 and 5; that District 4 Councilmember Elizabeth Ontiveros-Cole be appointed as the current Vice-Mayor; and the order for appointment for the next eightmonth term beginning on June 15, 2026, be Districts 6, 1, 2, 3, 5, and 4.
