The mission of Claremont After-School Programs, Inc. (CLASP) is to help elementary-school children enhance their academic, organizational and social skills by providing high-quality, after-school programs in Claremont Unified School District neighborhoods. The boundaries of CUSD overlap with part of Pomona's District 6, which includes affordable housing complexes, extended-stay hotels, and mobile home parks that are north and south of Foothill Boulevard and west of Towne Avenue. About 33% of our students live in this area.

We had 25 Pomona students in our program at the end of the school year. Our actual program cost is approximately \$1,600 per student, which translates to a cost of \$40,000 for the 25 Pomona students that we serve. The requested \$9,000 in our grant request covers the cost of 5 to 6 students.

CLASP offers in-person and Zoom sessions, providing after-school homework assistance and enrichment two days per week for 90 minutes each day. Children are admitted to CLASP because they have been identified by their teachers as students who have the greatest need for our services. Volunteer tutors work with one student at a time to help reduce the achievement gap that has widened for academically at-risk students due to COVID-19. This early intervention helps students gain the knowledge and skills they need to do well in the classroom.

One Pomona parent wrote: "CLASP has been instrumental in my child's academic improvement and confidence in problem solving. The staff and tutors provided a safe and caring environment that encouraged exploration and growth. Last year, my child faced many challenges. Acceptance into the CLASP program provided an environment that increased his self esteem. Programs such as yours are so beneficial and our family feels blessed to have been a part of it."

Thank you for your continued support of CLASP and the Pomona children that we serve.
