

RESOLUTION NO. 2025-86

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE ACCEPTANCE OF \$1,943,625 IN MENTAL HEALTH SERVICES ACT (MHSA) FUNDING FROM TRI CITY MENTAL HEALTH CENTER TO OPERATE 71 CRISIS SHELTER BEDS AT THE HOPE FOR HOME HOMELESS SERVICES CENTER (H4H), CARRYING OVER \$381,465 FROM FY 2045-25 TO FY 2025-26, AND INCREASING REVENUE ESTIMATES AND APPROPRIATIONS BY THE SAME AMOUNT

WHEREAS, on December 18, 2018, the Tri City Mental Health Center Governing Board entered into an agreement with the city of Pomona \$357,700 in Mental Health Service Act (MHSA) funding to reserve 28 crisis shelter beds at the Hope for Home Homeless Services Center; and,

WHEREAS, on December 2, 2019, the Tri City Mental Health Center Governing Board and the city of Pomona executed the First Amendment to the Agreement to change the term of the Agreement, and increase the number of shelter beds reserved from 28 to 31 for the exclusive use of Tri-City.; and,

WHEREAS, on July 1, 2022, the Tri City Mental Health Center Governing Board and the city of Pomona executed the Second Amendment to the Agreement extending the term of the Agreement for an additional three years ending on June 30, 2025; and,

WHEREAS, the City recognizes the need for Tri City, as the local mental health authority, to have access to the year-round crisis shelter beds at Hope for Home to accommodate 71 adult individuals enrolled as MHSA clients and deliver supportive service; and,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. Adoption of Resolution No. 2025-86 (Attachment No.1) will accept the Mental Health Service Act (MHSA) award from Tri City for a total \$1,943,625 for 71 crisis shelter beds from July 1, 2025 through June 30, 2026. Partial revenue estimates and appropriations for this program were approved as part of the FY 2025-26 budget process appropriating \$356,425 of the \$396,025 to fund 215-1791-52285-58681 for program operations and \$39,600 to fund 215-1702-52285-58681 for City administrative costs.

SECTION 2. Adoption of Resolution No. 2025-86 (Attachment No.1) will carryover the MHSA award from Tri City for a total \$381,465 from previous unspent funds to FY 2025-26.

SECTION 3. The FY 2025-26 revenue estimates and appropriations included in the following table details the fiscal impacts associated with the recommended action:

SECTION 4. Approves the City of Pomona to enter into an agreement allowing Tri City to reserve and pay for its exclusive use of 71 crisis shelter beds annually to eligible homeless individuals at the Hope for Home Homeless Services Center.

SECTION 5. Authorizes the City Manager to execute the agreement and any other documentation requested for acceptance of the award subject to approval as to form by the City Attorney.
