

RESOLUTION NO. 2025-83

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE ACCEPTANCE OF \$3,540,865 IN MEASURE A GRANT FUNDS FOR THE OPERATION OF THE INTERIM HOUSING PROGRAM AT HOPE FOR HOME HOMELESS SERVICES CENTER (H4H) AND AMENDMENT OF THE FY 2025-2026 OPERATING BUDGET

WHEREAS, on December 6, 2024, the Los Angeles Homeless Services Authority (LAHSA) released a request for proposal (RFP) for an Interim Housing contract to fund congregate and non-congregate shelters; and,

WHEREAS, the Interim Housing Program would be replacing the previous Bridge Housing and Crisis Housing Programs; and,

WHEREAS, on April 22, 2025, LAHSA notified the City of Pomona that its Hope for Home Homeless Services Center (H4H) would be funded for \$3,540,865.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. Authorize the acceptance of \$3,540,865 in the Los Angeles County Measure A fund for the operation of the Interim Housing Program at H4H.

SECTION 2. Amend FY 2025-2026 Operating Budget by increasing revenue estimates and appropriations per chart below:
