

RESOLUTION NO. 2017-

ADOPT A RESOLUTION AUTHORIZING THE ACCEPTANCE OF \$19,250 OF MEASURE H HOMELESS INITIATIVE FUNDS TO LOCALLY ADMINISTER THE HOMELESS INCENTIVE PROGRAM (HIP), AMENDING THE FY 2017-2018 OPERATING AND REVENUE NEIGHBORHOOD SERVICES BUDGET

WHEREAS, on June 13, 2017, the Board of Supervisors (“Board”) approved funding allocations for each of the Measure H eligible Homeless Initiative strategies that included an allocation to HACoLA for Strategy B4 - “Facilitate Utilization of Federal Housing Subsidies”; and,

WHEREAS, the Housing Authority County of Los Angeles (“HACoLA”) received Homeless Initiative, Strategy B4 Funding (the “Funding”) for Fiscal Year 2017-2018 from the County of Los Angeles (“County”); and,

WHEREAS, the City of Pomona Housing Authority (PHA) will be a sub-recipient of funds through the Los Angeles County’s recently passed Measure H funding; and

WHEREAS, the PHA will implement a Homeless Incentive Program (HIP) to assist homeless individuals and families with a Housing Choice Voucher with move-in costs and provide incentives to landlords to accept tenants with a voucher issued by the PHA.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. Approve the acceptance of \$19,250 in Measure H Homeless Initiative Funds to help house five homeless individuals and families which includes \$17,500 (139-1791-XXXX-0000) to pay for holding fees, move-in costs, credit and application fees and damage claims and approximately \$1,750 (139-1702-XXXXX-00000) in administrative fees to operate a Homeless Incentive Program.

SECTION 2. Amend the FY 2017-2018 Neighborhood Services Department budget by receiving and appropriating \$19,250 in Measure H Homeless Initiative Funds.

SECTION 3. The City Council authorizes the City Manager to execute the appropriate contracts and other documentation requested for acceptance of the award and operation of the above listed programs for submittal to the Housing Authority of the County of Los Angeles (HACoLA), subject to approval as to form by the City Attorney.

SECTION 4. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its approval.
