# SUBJECT: RESOLUTION TO AMEND THE FY 2023-24 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET AND OPERATING BUDGET BY CREATING A NEW PROJECT, "SKATE PARK AT KENNEDY PARK" AND APPROPRIATING \$155,000 OF GENERAL FUND TO THE PROJECT

## **RECOMMENDATION:**

It is recommended that the City Council adopt the following resolution:

RESOLUTION NO. 2024-76 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2023-24 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY CREATING A NEW CIP PROJECT, "SKATE PARK AT KENNEDY PARK," PROJECT NO. 428-2590-XXXXX-71102 AND AMENDING THE FY 2023-24 OPERATING BUDGET BY UNAPPROPRIATING \$155,000 OF GENERAL FUND HOURLY AND FURNITURE AND EQUIPMENT SAVINGS FROM CUSTODIAL SERVICES AND AFTERSCHOOL RECREATION (YOUTH), AND APPROPRIATING THIS \$155,000 TO THE NEW PROJECT

## **EXECUTIVE SUMMARY:**

Adoption of Resolution No. 2024-76 (Attachment No. 1) will create a new CIP project, "Skate Park at Kennedy Park," Project No. 428-2590-XXXXX-71102 (Project). It will also re-appropriate \$155,000 of General Fund from the operating budget to the new Project. The Project will provide for the construction of a skate park and associated amenities at John F. Kennedy Park (Kennedy Park).

#### **DISCUSSION:**

The City of Pomona (City) currently has two skate parks, one at Palomares Park and one at Martin Luther King, Jr. Park. The latter will be remodeled as part of the City's CIP Project "Martin Luther King, Jr. Park – Skate Park Expansion/Lights," Project No. 428-2590-XXXXX-71092. Upon completion, the new skate park at Kennedy Park (District 1) will be the third of its kind in the City.

At the Parks and Recreation Commission meeting on the March 21, 2024, the Commission heard a presentation on and discussed potential skate park and amenities expansion. At their next meeting on April 18, 2024, the Commission again discussed this topic and recommended that a skate park at Kennedy Park would be the best location for a variety of reasons, including its proximity to Marshall Middle School and Ganesha High School.

The Community Services Department has savings in the Hourly line items in their Custodial Services and Afterschool Recreation (Youth) funds and savings in the Furniture and Equipment line item in the Afterschool Recreation (Youth) fund. By using this money to develop a skate park at Kennedy Park, additional opportunities for youth programming will be available to facilitate exercise and additional recreational programming.
