RESOLUTION NO. 2022-198– A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ACCEPTING THE 2022 OFFICE OF COMMUNITY ORIENTED POLICING SERVICES TECHNOLOGY AND EQUIPMENT PROGRAM GRANT IN THE AMOUNT OF \$3,404,000 AND AMENDING THE FY 2022-23 OPERATING BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS IN THE AMOUNT OF \$3,615,352

WHEREAS, the Police Department has been awarded \$3,404,000 from the U.S Department of Justice (DOJ) Community Oriented Policing Services (COPS), Technology and Equipment grant; and

WHEREAS, a Sub-Recipient Agreement with DOJ is needed to fund the purchase and replacement of all Police field, portable and mobile radios;

WHEREAS the authority to accept grant funding and award a sole-source to Motorola Solutions, Inc. is vested with the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby enters into a Sub-Recipient Agreement with DOJ for the acceptance of \$3,404,000 and authorizing the City Manager, or designee, to execute the Sub-Recipient Agreement and any related documents on behalf of the City.

SECTION 2. That the City Council awards a sole-source purchase to Motorola solutions, Inc. in the amount of \$3,615,352 to purchase and replace field, portable and mobile radios

SECTION 3. That the City Council hereby amends the FY 2022-23 Operating Budget in the COPS Technology Equipment and American Rescue Plan Funds by increasing revenue estimates of \$3,404,000 and \$211,352 (129-2090-40875-00000 and 191-2090-40875-00000) and a corresponding appropriations in the amounts of \$3,404,000 and \$211,352 (129-2090-66189-00000 and 191-2090-66189-10015).

<u>SECTION 4.</u> The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
