California Waste Management Act

Due to budget cuts, this Initiative mandates a reduction of waste disposal away from landfills. The Los Angeles Regional Agency (LARA) is a consortium of 18 member cities in Los Angeles County to ensure the city meets and exceeds the waste diversion mandates set by the state.

Mayor's Task Force – Andrea Rico, Government & Community Affairs Manager

Frequency of meetings: Every Wednesday from 11:00 - 12:00; from 12:00 - 12:30 the mayor stays online as well as some staff to give community members an opportunity to discuss topics that might have been too sensitive to discuss in an open forum and to provide a safe space.

Purpose of task force:

Mayor Sandoval called community leaders and non-profits to come together under his leadership to discuss concerns pertaining to the Covid virus.

As the community faces new fears of Immigration concerns and how they are impacting our community, including how families and students who are not attending school, due to the growing fears.

Meetings are not recorded but minutes are taken; based on last meeting, looking to create subcommittees include discussing the Compassion Fund and addressing financial instability of both residents and small businesses being impacted.

Second, a subcommittee is Health Access to Physical and Mental Wellbeing of the community and the impacts of what is going on and to design community interventions which include, but not limited to, therapeutic art, walk in school bus, safe routes to schools due to immigration enforcement.

Third, Access to Housing and Food, the essential necessities. As families start to be impacted economically, the fears can lead to a housing financial crisis or loss of benefits based on removal or changes in policy.

Fourth, Proposed Data Collection and communication include storytelling and narratives. Subcommittee feels it's important to give voice to the community; experiences put a name to a face. Qualitative and quantitative data as decisions are made, decisions can be made in real time and data driven decisions on how best to appropriate funds or bring initiatives or make suggestions.

To avoid future altercations or erasure of history, archiving and record keeping of historical events, as tragic as this may be, due diligence is imperative.

Avoid false messaging or misinformation getting out to the community; changes to policy potential to losses of benefits, one wrong story/post to incite fear. Looking to do better in having one collective message meaning if the school district has one message, same message would be shared with the city, and the city would repeat the message as would the non-profits and partners should do as well.

Ms. Rico invited commissioners to participate in the meetings, and asked commissioners to provide the Commission Secretary with emails to be placed on the mailing list. This method will show commissioners how they can participate if they choose to do so.
