A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ACCEPTING THE STATE OF CALIFORNIA OFFICE OF TRAFFIC SAFETY SELECTIVE TRAFFIC ENFORCEMENT PROGRAM GRANT IN THE AMOUNT OF \$440,000 AND AMENDING THE FY 2023- 24 OPERATING BUDGET TO INCREASE REVENUE ESTIMATES AND APPROPRIATIONS IN THE AMOUNT OF \$440,000

WHEREAS, the State of California's Office of Traffic Safety (OTS) has awarded a Selective Traffic Enforcement Program (STEP) Grant to the City of Pomona to reduce the number of persons killed and/or injured in vehicle collisions involving alcohol, speed, red light violations and other driver behaviors. The grant period begins October 1, 2023, and continues through September 30, 2024; and,

WHEREAS, the total amount of \$440,000 will be used to achieve the goals of the grant through education, field operations and acquiring equipment;

WHEREAS, the authority to accept the Selective Traffic Enforcement Program Grant and amend the current revenue and operating budgets to appropriate the OTS grant funds to be received is vested with City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council hereby accepts a Selective Traffic Enforcement Program Grant award of \$440,000 and agrees to the terms and conditions of the grant agreement.

<u>SECTION 2.</u> The City Council hereby amends the FY 2023-24 Police Department's Miscellaneous Grant Fund budget to increase revenue estimates by \$440,000 (215-2014-40875- 58782), with a corresponding appropriation of \$440,000 (215-2014-XXXXX-58782).

<u>SECTION 3.</u> The City Manager, or designee, is hereby authorized to enter into the grant agreement on behalf of the City.

SECTION 4. The City Clerk shall attest and certify to the passage and adoption of this Resolution and it shall be effective immediately upon its approval.
