

**RESOLUTION NO. 2025-123**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, TO ACCEPT ELDERLY NUTRITION PROGRAM GRANT FUNDS FROM LOS ANGELES COUNTY FOR SENIOR MEAL SERVICES IN THE AMOUNT OF \$462,500 AND AMEND THE FY 2025-26 OPERATING BUDGET SENIOR NUTRITION GRANT FUND BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS IN THE AMOUNT OF \$54,300**

**WHEREAS**, the City's Elderly Nutrition Program (ENP) continues to provide free, nutritious meals to senior adults and adults with disabilities; and

**WHEREAS**, the County of Los Angeles County Aging and Disabilities Department (County) provided ENP Older Americans Act (OAA) Title III C-1 (Nutrition Services) funding in the amount of \$462,500 for FY 2025-26 in grant meal services reimbursement funding to City from the County;

**WHEREAS**, the FY 2025-26 Operating Budget currently includes County provided grant revenue and expenditures for the ENP.

**WHEREAS**, the FY 2025-26 Operating Budget currently includes Federal Nutrition Services Incentive Program provided grant revenue; which have been discontinued.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council accepts the County of Los Angeles baseline funding allocation for ENP services for the Subaward (No. ENP252607) Sum Year 1 (SSY 1) in the amount of \$462,500 for the FY 2025-26 ENP Grant.

**SECTION 2.** The FY 2025-26 Operating Budget shall be amended by increasing revenue estimates (226-4190-40857-00000) in the amount of \$92,135.

**SECTION 3.** The FY 2025-26 Operating Budget shall be amended by decreasing revenue estimates (226-4190-40844-00000) in the amount of (\$37,835).

**SECTION 4.** The FY 2025-26 Operating Budget shall be amended by appropriating funds to controllable contract services 226-4190-52285-00000 in the amount of \$54,300.

**SECTION 5.** The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
