REGULAR MEETING MINUTES For MAY 27, 2025

CALL TO ORDER

Chair Houston called the Community Life Commission meeting to order at 6:15 P.M.

Tri-City Mental Health Services Presentation

Sara Rodriguez, Mental Health Services Act Projects Manager at Tri-City Mental Health, presented updates on California's evolving behavioral health landscape, highlighting the implications of Proposition 1 and related legislative efforts. Proposition 1, originally passed in 2004, marks the first significant overhaul since the closure of many state mental hospitals. Its primary aim is to help transition the mental health sector into a broader behavioral health model, increasing access to services for a wider population. Funded by the "Millionaires Tax", a 1% tax on personal income exceeding \$1 million, with 10% of those funds allocated to states and then distributed to counties. The measure supports a range of community-based initiatives.

Key components include the Behavioral Health Infrastructure Bond Act, which allocates \$6.38 billion for constructing behavioral health housing and treatment facilities, and Senate Bill 326, focused on expanding housing services for individuals with severe mental illness, emotional disturbances, and substance use disorders. Sara extended a general invitation to commissioners, residents, and community partners to join monthly work groups that will help develop strategies for implementing these changes. Participants will receive a \$50 stipend per meeting.

During the presentation, several commissioners raised questions. Commissioner Phillips inquired about the focus on early intervention for ages 0–25 and was informed this demographic is historically underserved. When asked how the Cultural and Linguistic Competency (CLC) Committee could support these efforts, Rodriguez encouraged community staff to attend governing board meetings held in Pomona, Claremont, and La Verne. Commissioner Carrizosa questioned whether facilities like the former Lanterman Developmental Center might ever return, to which the response was uncertain. Commissioner Mendez asked about housing eligibility requirements; the answer emphasized that clients must already have active electronic health records and be currently receiving services. With ongoing changes, the agency is now able to accommodate multiple families through its programming, highlighting its expanding capacity

Cancellation Policy – Commission Meetings

Commissioner Carrizosa requested that an item be added to the next agenda regarding steps to create an ordinance for maintaining alleyways.
