

RESOLUTION NO. 2025-94

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AUTHORIZING THE ACCEPTANCE OF \$93,645 IN MEASURE A FUNDS TO ADMINISTER THE HOMELESS INCENTIVE PROGRAM (HIP) AND AMENDMENT OF THE FY 2025-26 OPERATING BUDGET

WHEREAS, on June 13, 2017, the Board of Supervisors (“Board”) approved funding allocations for each of the Measure H eligible Homeless Initiative strategies that included an allocation to the Los Angeles County Development Authority (“LACDA”) for Strategy B4 – “Facilitate Utilization of Federal Housing Subsidies”; and,

WHEREAS, on November 5, 2024, Los Angeles County voters approved the repeal of Measure H tax and its replacement with a 0.5% sales tax for Measure A, to fund a similar initiative titled “Expedited Placements in Permanent Housing for Persons Experiencing Homelessness”; and,

WHEREAS, the PHA will continue to be a sub-recipient of funds to implement the Homeless Incentive Program (HIP) to assist homeless individuals and families with a tenant-based voucher/certificate with move-in costs and provide incentives to landlords to accept tenants with a voucher/certificate issued by the PHA; and,

WHEREAS, the agreement for FY 2025-26 amends the funding source and increases the award amount; and,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. Approve the acceptance of \$93,645 in Homeless Initiative, Measure A Comprehensive Homelessness Services funds to help house fifteen homeless individuals and families, which includes \$8,513 (141-1702-XXXXX-65401) for administrative costs and \$85,132 (141-1791-XXXXX-65401) for program operations.

SECTION 2. Amend the FY 2025-26 Neighborhood Services Department operating budget changing the funding source to the appropriate accounts.
