#### CITY ATTORNEY REPORT OUT FROM CLOSED SESSION

City Attorney Carvalho stated that for Item A – Existing Litigation, City Council acknowledged receipt of 2.8 million settlement funds, and staff deposited that into the capital improvement reserve fund.

Ed Reece, San Gabriel Valley Council of Governments President gave the presentation.

### **MAYOR/COUNCILMEMBER COMMUNICATIONS**

Councilmember Canales announced upcoming events: 2<sup>nd</sup> Saturday Artwalk, Downtown Pomona District's Christmas Parade, Pomona Democratic League Awards, Cornhole Tournament Fundraiser hosted by the Pomona Chamber of Commerce, and the Palomares Park Haunted House event. Councilmember Canales also gave thanks to the Pomona Library and the Pomona Pride Center for the events they host. Lastly Councilmember Canales gave comments about Consent Calendar Items No. 2 and No. 3.

Councilmember Ontiveros-Cole attended the Pride Gala fundraising event hosted by the Pomona Pride Center and discussed October being Breast Cancer Awareness month, Bullying Awareness month and Domestic Violence Awareness month.

Councilmember Preciado announced upcoming pick-up basketball event at Centennial Park and invited folks to participate in the upcoming Pomona 5K fundraising event.

Councilmember Martin gave recognition to Los Angeles County Fire Dept. Chief Gamble. Councilmember Martin discussed a traffic incident near Lopez Elementary School, and requested, as a future agenda item, the consideration of placing a crossing guard at the intersection of Mission and White. Councilmember Martin discussed upcoming events: Assemblymember Rodriguez's Press Conference, Love Your Park Day at Soto Park, Hilda Solis's event for Hispanic Heritage month, and Cancer Awareness Fundraising event hosted by Pomona PD.

Councilmember Garcia advised last City Council meeting's proclamation for Hispanic Heritage month would be distributed to the Camara de Comercio and to the Pomona Economic Opportunity Center. Councilmember Garcia thanked people for attending the District 3 Area Commander meeting and gave thanks to Athens for hosting a clean-up event. Councilmember Garcia encouraged folks to complete the Street Safety Action Plan survey. Councilmember Garcia announced the Pomona Public Library is open again and invited folks to attend the Library's upcoming Trunk O' Treat event.

Vice Mayor Lustro attended the Athens clean-up event and announced an upcoming compost giveaway at the City Yard.

Mayor Sandoval gave comments about the city councilmembers' dedicated service to the community. Mayor Sandoval thanked Councilmember Preciado for working to bring the Pomona 5K fundraising event to Pomona, and thanked staff for their work.

#### **CITY MANAGER COMMUNICATIONS**

City Manager Scott gave a correction on Consent Calendar Item #6: the award amount of \$6.7 million listed on the agenda was incorrect, however the amount of \$6.5 million listed in the staff report was correct. City Manager Scott gave an update about the Safety Action Plan. City Engineer Arnold Dichosa gave additional comments about the survey for the Safety Action Plan. Lastly, City Manager Scott advised a joint ad-hoc meeting had taken place on October 2<sup>nd</sup> to discuss fire services.

#### **Spadra Cemetery Update**

Speaker: Benny Ayala, Pomona resident

Date: October 6, 2025

Topic: Spadra Cemetery - recent findings, historical boundaries, site access, and community

benefits

Honorable Mayor and Councilmembers,

Thank you for the opportunity to share a brief resident update regarding Spadra Cemetery. I'm speaking as a Pomona resident who spends time caring for and researching this historic site.

#### 1) Discovery outside the current fence line

- I recently found an old headstone base/holder just outside the existing cemetery fence.
   The stone is missing the headstone, but it bears weathered markings that appear to reference a lot number and row.
- A person experiencing homelessness in the area called out that it "belongs there" as I
  examined it. It's unclear how the base arrived at its current spot—it could be original to
  a portion of the cemetery that historically extended beyond today's fence, or it may have
  been moved and placed there at some point.
- Based on its age and wear, and historic aerial imagery, it appears consistent with the cemetery's time period and suggests that burial plots may have existed beyond the current fence.

#### 2) Historic deed and original boundaries

- I located an original deed from 1897 (Mr. Philips) describing the cemetery's boundaries. The deed places the cemetery acreage at approximately 11.2 acres.
- By comparison, the currently fenced area is roughly 4.69 acres, meaning about 7 acres lie outside today's fence but within the historic description. I am continuing research and will gladly share copies and a map overlay with City staff.

#### 3) Access road blocked by parked trains

- The access road to the site is frequently blocked by trains parked on the tracks, limiting safe entry for residents, researchers, and potential supervised tours.
- The Historical Society's annual, City-permitted cemetery tours previously generated about \$10,000-\$25,000 per year, funding preservation, education, and security. Losing access has eliminated this community benefit and revenue.

#### 4) A path forward - public benefit and basic infrastructure

• Over time, the community would like to see the site stewarded with a caretaker on-site (through the right partnership) and for the cemetery to be re-activated for future interments in a dignified, regulated manner that serves Pomona residents.

 To safely maintain and supervise the site, we will ultimately need paved access, restored water, and electrical service. (Water service previously existed but is no longer available.)

#### 5) Potential overlap with current development

- Based on the 1897 deed (~11.2 acres) and historic aerials, it appears current or proposed development may be occurring on land that is—or should be—part of Spadra Cemetery's historic boundary.
- This raises concerns about permanent impacts to the cemetery's integrity, the dignity of
  those interred, and the ability of residents to care for and interpret the site. I am willing
  to personally walk the site with City leaders to review the deed, show the physical
  indicators on the ground, and discuss how projects like the Trumark proposal could
  permanently affect the cemetery and surrounding neighbors, both those resting and
  those responsible for care.

#### Requests to the City

- 1. Coordinate with the railroad/operator to keep the access road clear or establish a reliable access protocol for City-approved activities.
- 2. Facilitate staff review of the 1897 deed and support a survey/parcel clarification to recognize the historic boundary.
- 3. Designate a City liaison to work with stakeholders on near-term safety and access, including trash mitigation and humane engagement with unhoused individuals near the site.
- 4. Explore options for basic utilities restoration (water/electric) and access paving through phased improvements, grants, or partnerships, or Trumark.
- 5. Review current and proposed development within the deed-described area and consider interim protections (e.g., conditions, pause, or setbacks) until the historic boundary is verified to avoid irreversible impacts.

#### Closing

Spadra Cemetery is a unique piece of Pomona's heritage with the potential to educate, honor families, and serve residents if we can restore safe access and align the site with its historic footprint. I am willing to meet you on-site to walk the area, review the deed, and discuss how nearby development could permanently impact the cemetery and those who care for it.

# Affidavit of Objection to Unsafe Red Curb Parking and Traffic Hazard

State of California County of Los Angeles

I, Alejandro Vasquez Anaya, being of sound mind and over the age of 18, hereby declare under penalty of perjury the following:

#### 1. Personal Information

1.1. I for the time being reside at the mobile home park located at 301 E. Foothill Blvd., City of Pomona, California 91767.

1.2. My parents, who are senior citizens and I, regularly use the mobile home park driveway located at 301 E. Foothill Blvd. Pomona, CA 91767.

#### 2. Observed Hazard

2.1. The City of Pomona has designated the curbs adjacent to the mobile home park driveway as red, indicating "No Stopping, Standing, or Parking at any time," pursuant to California Vehicle Code §21458(a)(1).

2.2. Despite this, the city has permitted vehicles associated with newlife church food drive to park along the red curb during events located at 275 E. Foothill Blvd. Pomona, CA 91767.

2.3. When vehicles are parked on these red curbs, our line of sight to the left and right is obstructed when exiting the mobile home park driveway, creating a serious traffic hazard.

2.4. This obstruction places me and other senior residents at substantial risk of collision and bodily harm when pulling out of our residences.

# 3. Government Actions Worsening the Hazard

3.1. I have contacted the Pomona Police Department and Planning Department regarding this issue. Both departments have failed or refused to enforce California Vehicle Code §21458(a)(1).

3.2. Instead of enforcing the law and removing vehicles from the red curb, a resident from the mobile home park mentioned that city council member Lorraine Canales has proposed restricting senior citizens from making left turns during the food drive, placing additional burden on residents rather than addressing the unlawful parking.

# 4. Legal and Constitutional Violations

- 4.1. By permitting selective enforcement of red curb laws in favor of Newlife church food drive while continuing to enforce them against residents and the public, the City of Pomona is engaging in unequal application of law in violation of the Fourteenth Amendment Equal Protection Clause.
- 4.2. By knowingly creating and maintaining hazardous traffic conditions, the City is depriving the residents of the mobile home park of their property right to safe ingress and egress, in violation of the Fourteenth Amendment Due Process Clause.
- 4.3. The City's actions constitute a public nuisance by allowing a condition that endangers the health and safety of the public, particularly senior residents.
- 4.4. If injury occurs, such deliberate disregard may expose the City to liability under 42 U.S.C. §1983 for violation of civil rights.

#### 5. Demand for Relief

- 5.1. I demand that the City of Pomona immediately cease allowing vehicles to park along the red curbs at 301 E. Foothill Blvd. Pomona, CA 91767 during Newlife church food drives or any other events.
- 5.2. I demand that the City enforce California Vehicle Code §21458(a)(1) equally, without favoritism or selective exemption.
- 5.3. I reserve all rights to pursue further remedies in state or federal court should this unlawful hazard continue.

#### 6. Declaration

I declare under penalty of perjury under the laws of the State of California and the United States of America that the foregoing is true and correct.

Honorable Mayor and Members of the Pomona City Council:

I respectfully submit this statement in opposition to the recent decision to delegate the selection of Police Oversight Commissioners to a subcommittee of three councilmembers.

As one of the individuals who participated in the 2020 Charter Review Commission that drafted the original ordinance, I can affirm that this new procedure does not reflect the intent or spirit of what was created.

Section 2-652(a) of the Pomona Municipal Code is clear:

"The commission shall be comprised of five members appointed by a majority vote of the City Council."

The drafters intentionally limited the Commission to five members rather than seven, to ensure that the entire Council—not a subset—would evaluate and appoint each commissioner collectively. This design was meant to safeguard independence, prevent political influence, and maintain public confidence in the Commission's work.

Had staff or counsel reviewed the 2020 Charter Review Commission's meeting minutes and video recordings, they would find that the Commission discussed and rejected any process that could give undue influence to individual councilmembers or small groups. That historical record demonstrates that the current approach is inconsistent with the original vision.

Delegating appointment authority to a three-member subcommittee undermines transparency, concentrates decision-making power, and erodes the trust that the Police Oversight Commission was created to build. It also conflicts with the **Brown Act's principles** of open and collective governance, which require that decisions representing the public interest be made publicly and by the full body.

I respectfully urge this Council to restore compliance with both the letter and intent of Section 2-652 by ensuring that all appoints to the Police Oversight Commission are made by the entire City Council, in open session, without subcommittee control or political influence.
