EXECUTIVE SUMMARY:

The Housing Services Division manages and implements over 15 grants each year, which together total more than \$30 million. As the FY 2024-25 fiscal year ended, staff found unspent funds that

were budgeted for various activities. These funds must now be appropriated in the FY 2025-26 budget so they can be spent. The money comes from projects that were either in progress when the new fiscal year began or from programs that did not fully use their funding during the last fiscal year. This report, therefore, requests that the fund balances in the FY 2025-26 City Operating Budget and the FY 2025-26 Capital Improvement Program (CIP) Budget be amended.

FISCAL IMPACT:

Adoption of Resolution No. 2025-113 (Attachment No. 1) will amend the FY 2025-26 City Operating Budget by adjusting revenue estimates and appropriations to balance housing programs with the available amounts in HHPG and HOME-ARP funding.

Amendments to accounts are based on the current grant award for each program. The amounts listed in the chart below will amend the accounts so that budgeted expenditures equal revenue in FMS and subsequently equal the amount for the current grant term and fiscal year. Unexpended funds will be used for projects and activities that are eligible under each funding source that are currently administered by the City.

PREVIOUS RELATED ACTION:

On June 2, 2025, the City Council adopted the FY 2025-26 City Operating Budget and FY 2025-26 Capital Improvement Program (CIP) Budget.

Amending the Fiscal Year (FY) 2025-26 City Operating Budget FY 2025-26 Capital Improvement Program (CIP) Budget with HHPG and HOME-ARP Funds

DISCUSSION:

The City of Pomona currently receives Healthy Homes Production Grant (HHPG) funds and Home-Recovery Program (HOME-ARP) funds from the U.S. Department of Housing and Urban Development (HUD). The HHPG grant ended on September 1, 2025, which means unexpended funds in FY 2024-25 need to be carried forward to FY 2025-26 to allow the City to fully expend funds in the current year.

HOME-ARP program funds are budgeted for the rehabilitation of the 252 E. 4th Street project, along with supportive services and administration. However, a review of actual expenditures from FY 2024-25 revealed that various revenues and expenditures were overestimated in the FY 2025-26 City Operating Budget and Capital Improvement Program (CIP) Budget. To align the FY 2025-26 City Operating Budget and Capital Improvement Program (CIP) Budget with the available HOME-ARP funding, adjustments will be made by decreasing revenue estimates and appropriations to match the appropriated expenditures.
