SUBJECT: AGREEMENT WITH LOS ANGELES COUNTY METROPOLITAN

TRANSPORTATION AUTHORITY TO PROVIDE PROPOSITION C FUNDING AND APPROPRIATE FUNDING TO "STREET REHABILITATION – DISTRICTS 2 AND 3" PROJECT NO. 428-2590-

RECOMMENDATION:

It is recommended that the City Council take the following actions:

- 1) Enter into a Fulfillment Agreement of Proposition C Funds with Los Angeles County Metropolitan Transportation Authority (Metro) for the provision of \$458,569 of Proposition C Funds to the City of Pomona (City); and
- 2) Adopt the following resolution:

RESOLUTION NO. 2025-127 – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING FY 2025-26 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS BY A TOTAL OF \$458,569 OF LOS ANGELES COUNTY METROPOLITAN TRANSPORTATION AUTHORITY PROPOSITION C FUNDING AND APPROPRIATING THIS FUNDING TO "STREET REHABILITATION – DISTRICTS 2 AND 3," PROJECT NO. 428-2590-XXXXXX-67935; and

3) Authorize the City Manager, to execute the agreement and any subsequent documents or amendments, subject to approval by the City Attorney.

EXECUTIVE SUMMARY:

Approval of these actions will allow the City to enter into an agreement (Attachment No. 1) with the Los Angeles Metropolitan Transportation Authority (Metro) to receive \$458,569 of Proposition C funding to replace STP-L funding due to a corrective order issued to SCAG by the Federal Government. This funding will then be appropriated via the resolution (Attachment No. 2) to "Street Rehabilitation – Districts 2 and 3," Project No. 428-2590-XXXXX-67935.

DISCUSSION:

Metro has historically apportioned, on an annual basis, \$31 million of Federal Surface Transportation Block Grant (STBG) funds to agencies in Los Angeles County based on population through the Surface Transportation Program – Local (STP-L) funding program. In 2021 and 2022, the federal government issued a corrective action to Caltrans and the Southern California Association of Governments (SCAG), finding that the practice of allocating STP-L by population was out of compliance with STBG requirements. When this took effect, it prevented agencies from programming and accessing their unprogrammed STP-L balances through the Federal Transportation Improvement Program (FTIP). The Metro Board of Directors decided at their April 24, 2025 meeting to approve using Proposition C funds to fulfill \$458,569 of unprogrammed STP-L balance for the City of Pomona.

It was anticipated that the City would receive STP-L funding for "Street Rehabilitation – Districts 2 and 3" Project No. 428-2590-XXXXX-67935, which provides for the rehabilitation of City Streets within Districts 2 and 3 per the City's Pavement Management Program. Therefore, through this agreement, Proposition C funding will be allocated to this project and will replace the STP-L funding which the City would have otherwise received.
