Recommendation to City Council for Removal of Arwa Hammad from the Board of Library Trustees Due to Number of Absences From Meetings During the 2024 Calendar Year, in Accordance with Attendance Policy in the Standard Bylaws. Ms. Torres reported that Arwa Hammad resigned from the Board of Library Trustees via email, effective 9/12/24.

Ms. Torres announced that Crystal will be traveling to Ohio to attend a Youth Summit for children's library staff training and development. Pomona Public Library received a grant from the State in the amount of \$1,000 to cover the majority of the costs.

530. Library Infrastructure Project Update – Mr. Gluba reported the City has awarded a contract and the new tentative project start date is now March 2025.
