RESOLUTION NO. 2023-161– A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2023-24 SAFE CLEAN WATER PROGRAM SUPPLEMENTAL BUDGET BY APPROPRIATING \$14,404 OF MEASURE W (SAFE CLEAN WATER PROGRAM) FUND RESERVES TO PURCHASE ONE NEW UTILITY TRUCK FOR THE WATER RESOURCES DEPARTMENT, ENVIRONMENTAL SECTION

WHEREAS, in November 2018, Measure W (Safe Clean Water Program) was approved by Los Angeles County voters to improve water quality in a manner that achieves additional benefits such as increasing water supply and investing in the health and well-being of Los Angeles County communities;

WHEREAS, on July 17, 2023, City Council approved the operating budget which included the Measure W (Safe Clean Water Program) budget for FY 2023-24. In the budget included \$52,000 to purchase a vehicle for the Water Resources Department (WRD), Environmental section; and

WHEREAS, the City Council desires to amend the FY 2023-24 Measure W (Safe Clean Water Program) budget by appropriating \$14,404 from available reserves in Measure W Fund thereby increasing funding to \$66,404 and purchasing a utility truck for the WRD, Environmental section stormwater maintenance operations.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council amends the FY 2023-24 Adopted Budget by appropriating \$14,404 from available reserves in Measure W (Safe Clean Water Program) fund to add to the \$52,000 current budget in account 142-8130-66182-00000; thereby fully fund and allow for purchase of a utility truck for the Environmental section.

SECTION 2. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
