## **RESOLUTION NO. 2017-33**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, ESTABLISHING THE ORDER OF APPOINTMENT OF VICE MAYOR AND SELECTING AND DESIGNATING DISTRICT 5 COUNCILMEMBER, GINNA E. ESCOBAR AS VICE MAYOR

**WHEREAS,** Ordinance No. 3662 was adopted on August 3, 1992, establishing a process for selecting and designating a member of the City Council to serve as Vice Mayor;

WHEREAS, an eight month period has lapsed requiring the appointment of a new Vice Mayor by the City Council, pursuant to Article II, Section 2-41 (a) of the Pomona City Code;

WHEREAS, Ordinance No. 3662 specifies that "If two or more new Councilmembers are added to the order at the same time, their position on the order shall be determined by listing their respective Council districts in descending numerical order."

WHEREAS, as a result of the November 7, 2016 election, new Councilmembers for Districts 1, 4, and 6 took office on December 14, 2016, thereby changing their position on the order in descending numerical order.

WHEREAS, according to the order of appointment set forth in Resolution 2016-60, the next designated Vice Mayor would be the Councilmember from District 3;

WHEREAS, Pomona City Code Section 2-41(d) allows a designated candidate for Vice Mayor rotation to decline appointment; and Councilmember Cristina Carrizosa from District 3 has advised she wishes to decline appointment as Vice Mayor, pursuant to such section; therefore the position of District 3 moves to the end of the in the Vice Mayor rotation list;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona, California, as follows:

<u>SECTION 1</u>. That pursuant to Pomona City Code, Section 2-41(b), the order of appointment for the selection and appointment of Vice Mayor, as set forth in Resolution 2016-60, is as follows:

- 1. Councilmember from District 2 (As of June 6, 2016)
- 2. Councilmember from District 3
- 3. Councilmember from District 5
- 4. Councilmember from District 1
- 5. Councilmember from District 6
- 6. Councilmember from District 4

SECTION 2. That pursuant to Pomona City Code, Section 2-41(b), the order of appointment for the selection and appointment of Vice Mayor, following the certification of the November 7, 2016 election was as follows:

- 1. Councilmember from District 2
- 2. Councilmember from District 3
- 3. Councilmember from District 5
- 4. Councilmember from District 6 (New councilmember)
- 5. Councilmember from District 4 (New councilmember)
- 6. Councilmember from District 1 (New councilmember)

SECTION 3. That pursuant to Pomona City Code Section 2-41(d), because Councilmember Carrizosa, as the Councilmember from District 3, has chosen to decline the appointment of Vice Mayor, the order of appointment for the designation of Vice Mayor shall be as follows until such time the Council reorders the rotation for Vice Mayor:

- 1. Councilmember from District 5
- 2. Councilmember from District 6
- 3. Councilmember from District 4
- 4. Councilmember from District 1
- 5. Councilmember from District 2
- 6. Councilmember from District 3 (Declined appointment)

<u>SECTION 4.</u> That the City Council hereby selects and designates Ginna E. Escobar, Councilmember from District 5, to serve as Vice Mayor for an eight (8) month period, commencing on the date of adoption of this resolution.

<u>SECTION 5</u>. That in accordance with Pomona City Code Section 2-41(b), the order for the next selection and appointment of Vice Mayor shall be as follows:

- 1. Councilmember from District 6
- 2. Councilmember from District 4
- 3. Councilmember from District 1
- 4. Councilmember from District 2
- 5. Councilmember from District 3
- 6. Councilmember from District 5

**SECTION 6.** The City Clerk shall certify to the passage and adoption of this resolution and it shall thereafter be in full force and effect.
