SUBJECT: RESOLUTION TO AMEND THE FY 2025-26 CAPITAL IMPROVEMENT

PROGRAM (CIP) BUDGET BY UNAPPROPRIATING FUNDING FROM "MEMORIAL PARK BUILDING RENOVATION AND RETROFITTING," AND APPROPRIATING FUNDING TO "POMONA LIBRARY FACILITY IMPROVEMENTS" TO PROVIDE OFFICE SPACE FOR COMMUNITY

RECOMMENDATION:

It is recommended that the City Council adopt the following resolution:

RESOLUTION NO. 2025-96 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, TO AMEND THE FY 2025-26 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY UNAPPROPRIATING \$448,244 OF GENERAL FUNDS FROM "MEMORIAL PARK BUILDING RENOVATION AND RETROFITTING," PROJECT NO. 428-2590-XXXXXX-71084, AND APPROPRIATING THIS \$448,244 OF GENERAL FUND TO "POMONA LIBRARY FACILITY IMPROVEMENTS," PROJECT NO. 428-2590-XXXXXX-74120

EXECUTIVE SUMMARY:

City Council adoption of Resolution No. 2025-96 (Attachment No. 1) will unappropriate \$448,244 from "Memorial Park Building Renovation and Retrofitting," Project No. 428-2590-XXXXX-71084, and appropriate it to "Pomona Library Facility Improvements," Project No. 428-2590-XXXXX-74120 to provide office space for Community Services staff temporarily housed at Mendoza.

DISCUSSION:

Several years ago, Community Services Staff outgrew the office space at Palomares Park due to staff expansion from grant funding and expanding program needs. Community Services Outdoor and Active staff were temporarily assigned to work out of *Mendoza*, a former Pomona Unified School District (PUSD) elementary school site. Community Services staff have been at the Mendoza location for about 13 months. However, staff must relocate to another site as their occupancy deadline is December 2025.

The initial plan involved setting aside General Fund programmatic/budget savings from Community Services for several fiscal years to fund a project to develop additional office space. The first location identified was the building at Memorial Park. The plan development process was started and revealed foundational, structural, and roof framing issues for the unreinforced masonry building. Unfortunately, costs to improve Memorial Park's building and make it structurally sound to safely occupy, were well beyond the original estimates and funding available in "Memorial Park Building Renovation and Retrofitting," Project No. 428-2590-XXXXXX-71084.

After determining Memorial Park was not economically viable, Staff looked at several options for Community Services office space. Improvements to the basement in the Library, where the Community Services Recreation Team is currently located, will include Outdoor and Active team members to collocate, enabling almost the entire Community Services youth-serving team to be in the same location, increasing teamwork and communication. This solution has been made possible with the partnership of the Library Team who are sharing space, the Police Department Internal Affairs who will be relocating within the building, and Community Services. Potential improvements include renovations to the basement to allow for more organization and functional work areas for both the Police Department Internal Affairs staff and Community Services staff. These basement improvements include new efficient lighting, ceiling tiles, door updates for ingress/egress, office furniture/fixtures, flooring, and the proper removal and disposal of old materials.

Approval of Resolution No. 2025-96 will provide additional funding to "Pomona Library Facility Improvements," Project No. 428-2590-XXXXX-74120 offering additional office space for Community Services staff from the Outdoor and Active Program as intended with the original project.
