**RESOLUTION NO. 2025-19 – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2024-25 WATER FUND BUDGET INCREASING REVENUE ESTIMATES AND APPROPRIATIONS BY A TOTAL OF \$63,000: \$60,000 FOR THE MEMBER AGENCY ADMINISTERED INCENTIVE PROGRAMS FOR THE RESIDENTIAL LANDSCAPE EVALUATION PROGRAM AND RESIDENTIAL WATER CONSERVATION KITS; \$3,000 FOR THE COMMUNITY PARTNERING PROGRAM**

**WHEREAS**, the Pomona City Charter requires that amendments to the Adopted Budget be approved by resolution, with approval of the Pomona City Council;

**WHEREAS**, the Metropolitan Water District (MWD) is offering grant funds for the Member Agency Administered Incentive Programs (MAAP); Residential Landscape Evaluation Program and Residential Water Conservation Kits in the amount of \$60,000;

**WHEREAS**, the City is offering an extension of a highly successful program conducted in 2024;

**WHEREAS**, the City was awarded \$3,000 for the Community Partnering Program via MWD grant funds that will support our initiative to provide Pomona Unified School District students at Emerson Middle School with access to the Wyland Mobile Learning Experience; and

**WHEREAS**, said grant funds will foster water conservation awareness in the context of our residents' yards and homes.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council hereby amends the FY 2024-2025 Water Fund Revenue budget, by increasing revenue estimates by receiving and allocating \$63,000 (571-8127-40380-51356) from the following MWD reimbursable grants: Member Agency Administered Incentive Program and the Community Partnering Program.

**SECTION 2.** The City Council hereby amends the FY 2024-2025 Water Fund Operating budget by appropriating \$63,000 (571-8127-52197-51356) from Water fund.

**SECTION 3.** The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
