#### DISCUSSION ITEMS

#### 1. 2025 Watercolor Contest Commission Award

Arts Coordinator Ayala stated that the submission ended last Thursday, and we have received 16 submissions for your review.

The Commission took some time to view and vote on the artwork located on the second floor.

Arts Coordinator Ayala tally the votes, and the winner was Artist Brooke Duran, "Mother and Daughter" Mural.

## 2. Update on Action Plan 2020-2025/Priority Investment List

Deputy Director Khan provided an update on Goal 1 – Goal 5 of the Action Plan 2020/2025, which consists of Investments, Process, Equity, Communication and Youth. He mentioned that

about 55% of the Action Plan has been implemented.

Deputy Director Khan stated that the recommendation tonight is to receive and file the status update and to receive a report from staff on the remaining work plan. He said we have eight action steps that we need to work on:

- 1. A Call for Ad Hoc Community Members launched by May 2025
- 2. Work towards completing the 2022 Call for Art
- 3. Work towards completing the 2024 Open Call
- 4. Complete Hamilton Park Call for Art
- 5. Complete Garey Underpass (Area 1) Call for Art
- 6. Chalk Art Festival scheduled for November 8, 2025
- 7. Preservation Call for Consultants
- 8. Facilitate a discussion with the Commission and the Community on how to move forward the next five years.

Arts Coordinator Ayala stated that Ben Frank was originally approved to place a large Mural across the community center at Memorial Park. She mentioned that he is unable to do this, because the building is labeled as a Capital Improvement Project. She stated that the building is very old and located in the historic district and it is possible it might be demolished. She said this location is no longer viable.

Deputy Director Khan stated that we are in the design phase for the City's parking lot across from Mi Cafecito. He said in addition Public Works is considering building a bridge on Mission by the 71 freeway and have included us with CalTrans. He stated that we are in contact with the bridge aesthetics team. He mentioned in the next couple of months we will bring forward concepts to the Commission.

She stated we found a new space for Alan Estrada, "Together We Rose" Mural. She provided updates on the four remaining Murals and preservation of Murals.
