City Clerk responded to Commissioner Carrizosa's inquiry to move placement of ads to the front of Recreational Guide to convey to Councilmember Canales to discuss w/ City Manager

City Clerk received confirmation that the template sent by Houston will be in Fall Recreational Guide with the following changes:

COMMISSIONER COMMUNICATION

Commissioner Carrizosa

Growing concern regarding the illegal mini motorbikes; bikes have no muffler which allows the motor to be extremely loud when accelerating the gas and no helmets are being worn by the individuals riding these bikes

City Clerk suggested that the commissioner attend a council meeting and bring concern forth to council's attention.

Commissioner Carrizosa asked if police staff can participate as a liaison on the commission and City Clerk's response was, "No", due to budgetary cuts.

Commissioner Carrizosa researched the Alleyway Maintenance Ordinance and shared a letter sent out by Code Enforcement to the surrounding residents, instructing them to maintain their portion of the alleyway. A noticeable effect was observed after the letter was sent out.

Commissioner Umanzor

Commissioner informed commission she will bring forth the motorbike concerns at the next Commander's meeting within her district as well as share the Alley Maintenance letter.

Many violations on the Denny's property located on Gillette; owner of Dennys is responsible for the issues but have been unsuccessful contacting the owner.

Council member Martin conveyed the Ganesha Park stairs will be completed by Fall and flashing lights will be added to illuminate the areas in the park.

Councilmember Martin is working with Cal Trans to prevent Park and Ride from being a location for illegal dumping; one side of the street of the Park and Ride is blocked to all cars and mobile homes.

Volunteer dates in Ganesha Park will be brought forth once determined.

Council voted to have staff research other fire agencies to replace our LA County Fire, only no vote (6:1); Council member Martin was opposed. In this regard, the City Clerk conveyed to the Commissioners that nothing has been set in stone, but a large part is due to budgetary concerns; the contract expires next year
