## **RESOLUTION NO. 2025-109**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FISCAL YEAR 2025-26 OPERATING BUDGET BY APPROPRIATING \$58,000 FROM THE GENERAL FUND RESERVES AND ESTABLISHING THE COMPASSION FUND

WHEREAS, the Compassion Fund program is funded through the City's General Fund and is considered a discretionary expenditure. The City Council has the authority to allocate General Fund dollars toward any initiative that serves a public purpose. This program seeks to prioritize critical support for vulnerable residents and businesses during a period of heightened uncertainty and financial distress, reaffirming the City's commitment to the well-being of all members of the Pomona community

**WHEREAS**, in response to recent Federal activities, the Mayor and Council have expressed interest in establishing a Compassion Fund to provide financial assistance to assist the city's immigrant community and businesses that have been impacted by Federal developments; and

**WHEREAS**, at their August 4, 2025 City Council meeting, the City Council agreed to seed the Compassion Fund with a total of \$120,000 from general fund dollars; and

**WHEREAS**, a total of \$62,000 from the Mayor and Council's discretionary fund will be transferred to the Compassion Fund; and

**WHEREAS**, the City Council desires to amend the Fiscal Year 2025-26 Operating Budget by appropriating the remaining \$58,000 from the General Fund Reserves toward the Compassion Fund; and

**WHEREAS**, awarding agencies will administer the Compassion Fund, as directed by the City Council and overseen by the City Manager, who will define the distribution, auditing, and reporting requirements.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council amends the FY 2025-26 Operating Budget by appropriating \$58,000 from the General Fund Reserves (101-1302-52115-00000) to establish the Compassion Fund.

**SECTION 2.** The City Council does hereby authorize the City Manager, or her designee, to execute all required Funding Agreements and/or Memorandums of Understanding (MOUs) to facilitate the Compassion Fund program with the awarding agencies.

**SECTION 3.** The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
