**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, TO AMEND THE FY 2025-26 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY CREATING A NEW CIP PROJECT, “ROOF AND FACILITY REHABILITATIONS - FIRE STATIONS,” FD428 CIP PROJECT FUND | CC2590 CIP | WORKTAG: PRJ-00016 AND APPROPRIATING \$140,000 OF AVAILABLE GENERAL FUND RESERVES TO THE PROJECT**

**WHEREAS**, the City Council desires to create a new CIP Project, “Roof and Facility Rehabilitations - Fire Stations,” FD428 CIP Project Fund | CC2590 CIP | Worktag: PRJ-00016;

**WHEREAS**, the City Council desires to provide funding for the as needed repairs and roof replacements at City Fire Stations;

**WHEREAS**, based on a recent request from the Los Angeles County Fire Department which occupies City Fire Stations and a field review by City Staff, Fire Station 183 has been determined as a priority roof replacement to prevent building damage due to active water leaks; and

**WHEREAS**, the City Council desires to amend the FY 2025-26 CIP Budget by appropriating \$140,000 of available General Fund Reserves to CIP “Roof and Facility Rehabilitations - Fire Stations,” FD428 CIP Project Fund | CC2590 CIP | Worktag: PRJ-00016.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Pomona as follows:

**SECTION 1.** The City Council amends the FY 2025-26 CIP Budget by creating a new CIP Project, “Roof and Facility Rehabilitations - Fire Stations,” FD428 CIP Project Fund | CC2590 CIP | Worktag: PRJ-00016.

**SECTION 2.** The City Council amends the FY 2025-26 CIP Budget by appropriating \$140,000 of available General Fund Reserves (FD101 General Fund | CC2590 CIP | SC263 Transfer to CIP) to CIP “Roof and Facility Rehabilitations - Fire Stations,” FD428 CIP Project Fund | CC2590 CIP | RC116 Transfer from General Fund | Worktag: PRJ-00016.

**SECTION 3.** The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
