RESOLUTION NO. 2026-06 – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA AMENDING THE FY 2025-26 BUILDING AND EQUIPMENT REPLACEMENT FUND TO INCREASE APPROPRIATIONS BY \$459,000 FROM BUILDING AND EQUIPMENT REPLACEMENT FUND RESERVES

WHEREAS, the City of Pomona’s Vehicle Replacement Policy and Procedure on April 4, 2016, establishing criteria to justify the purchase of replacement vehicles citywide; and

WHEREAS, an approval for a sole source purchase from Carville Chrysler Dodge Jeep Ram Dealership in the amount of \$459,000 and vehicle builds to 10-8 Retrofit Inc. will allow for the purchase and building of six (6) Police Utility Vehicles for the Police Department. Approval on this item will increase appropriations in FY 25-26 Building and equipment fund in the amount of \$459,000 from the Building and Equipment Fund balance;

WHEREAS the authority to approve the sole-source purchases and increase appropriations in FY 25-26 Building and Equipment Replacement Fund is vested with the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby approves the sole-source purchase to Carville Chrysler Dodge Jeep Ram Dealership in the amount of \$258,000 and vehicle builds to 10-8 Retrofit, Inc. for six (6) Police Utility Vehicles for the Police Department for a total amount of \$459,000.

SECTION 2. That the City Council hereby amends the FY 25-26 Building and Equipment Replacement Fund FD434, Equipment Replacement Fund | CC2010, Patrol Services | Automobiles & Trucks by increasing appropriation in the amount of \$459,000 from the Building and Equipment Replacement Fund reserves.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
