

RESOLUTION NO. 2022-209

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FISCAL YEAR (FY) 2022-23 CITY OPERATING BUDGET TO INCREASE REVENUE ESTIMATES AND APPROPRIATIONS IN THE AMOUNT OF \$280,219 IN COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) AND EMERGENCY SOLUTIONS GRANT (ESG) AND MEASURE H FUNDS

WHEREAS, it is the desire of the City Council to amend the FY 2022-23 Adopted Operating Budget for various grant funds and projects; and

WHEREAS, the City Council must find that under the Federal guidelines established by the U.S. Department of Housing and Urban Development, the proposed changes are eligible uses of CDBG and Emergency Solutions Grant (ESG) funds and Measure H Funds will serve low- to moderate-income persons and/or areas; and

WHEREAS, based on the foregoing, the City Council desires to allocate the unexpended funds to eligible projects.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Pomona, as follows:

SECTION 1. The City Council amends the (FY) 2022-23 Operating Budget to increase revenue estimates and appropriate funding as follows:
