

RESOLUTION NO. 2025-84

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2025-26 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY CLOSING “TRAFFIC SIGNAL POLE REPLACEMENT – CITYWIDE,” PROJECT NO. 428-2590-XXXXX-68579 AND REAPPROPRIATING THE BALANCE OF MEASURE M FUNDS, IN THE AMOUNT OF \$441,106, TO “GAREY AVENUE REHABILITATION – ALISO STREET TO MONTEREY AVENUE,” PROJECT NO. 428-2590-XXXXX-68573

WHEREAS, the City desires to close existing project “Traffic Signal Pole Replacement – Citywide,” Project No. 428-2590-XXXXX-68579; and

WHEREAS, the City desires to amend the FY 2025-26 CIP Budget by re-allocating unexpended Measure M funding from “Traffic Signal Pole Replacement – Citywide,” Project No. 428-2590-XXXXX-68579 to “Garey Avenue Rehabilitation – Aliso Street to Monterey Avenue,” Project No. 428-2590-XXXXXX-68573.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council hereby amends the FY 2025-26 CIP Budget by approving the closing of “Traffic Signal Pole Replacement – Citywide,” Project No. 428-2590-XXXXX-68579 and unappropriating \$441,106 of Measure M funding (138-2590-89987-68579 CR, 428-2590-80878-68579 DR, 428-2590-66196-68579) from the project.

SECTION 2. The City Council amends the FY 2025-26 CIP Budget by appropriating \$441,106 of unexpended Measure M Funds (138-2590-89987-68573, 428-2590-80878-68573 and 428-2590-66196-68573) to “Garey Avenue Rehabilitation – Aliso Street to Monterey Avenue,” Project No. 428-2590-XXXXX-68573.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
