**SUBJECT: APPROVE SOLE SOURCE VENDORS FOR FISCAL YEAR 2026-27 TO
SUPPLY UNIFORMS, EQUIPMENT AND SERVICES FOR THE
POMONA POLICE DEPARTMENT**

RECOMMENDATION:

It is recommended that the City Council approve sole-source vendors to supply uniforms, equipment, and services for the Pomona Police Department.

EXECUTIVE SUMMARY:

Action on this item will approve sole-source vendors for Fiscal Year 2026-27 to supply equipment, uniforms, and services for the Pomona Police Department.

FISCAL IMPACT:

This action has no additional fiscal impact. Annual expenditures used shall be funded in accordance with the Police Department's adopted yearly operating budget.

PREVIOUS RELATED ACTION:

On June 16, 2025, the City Council approved the Police Department’s sole-source vendors to supply equipment, uniforms, and services for the department’s sworn and professional staff.

DISCUSSION:

The Police Department requests approval to designate several vendors as sole-source providers for specific equipment, uniforms, and services essential to departmental operations. Approval by the City Council will streamline access to these items and services for the Pomona Police Department. This designation will enable the issuance of annual purchase orders ranging from \$5,000 to \$100,000 per vendor, starting with the new fiscal year. The Police Department is seeking approval for the following vendors:

Advanced Systems Services, Inc.	Maintenance and repairs for the Police Department's Mobile Incident Command Center (MICC).	No other police vendors are familiar with the build and design of the MICC. Advanced Systems Services, Inc. provides services to mobile command centers for several neighboring law enforcement agencies and has regional warranty and service centers for municipal government equipment.
Adlerhost International, Inc.	Training for department canines to ensure K9 teams maintain proper skill levels and adhere to the “industry standard,” along with supplies and boarding options. Its convenient location also helps reduce overtime and travel costs for police personnel.
Ariana Aviation	Aero Bureau- Helicopter Services	Ariana Aviation is the exclusive provider responsible for servicing the aircraft gauges to ensure accurate readings, perform repairs, and complete necessary upgrades. These services are essential for

		maintaining safe navigation and compliance with FAA-mandated regulations.
Armorerlink (DBA Ganete Solutions)	Firearm Management Systems Software.	Armorerlink is the sole provider of the firearm and equipment tracking software. This software is used to keep accurate records of all weapons owned by the police department. It tracks inventory and ensures everything is properly accounted for. As a proprietary system, it is the best tool to meet the department's needs.

Ensuring reliable, cost-effective service, particularly during emergency situations.

Blakenship Police Supply (BPS) Tactical, Inc.	External patrol vest.	BPS provides durable external patrol vests designed to enhance officer safety and comfort during field operations. It is the only police vendor capable of delivering fully custom vests that meet the specific needs and specifications of the Pomona Police Department while aligning with its uniform policy.
BRINC Drones, Inc.	UAV/Drone.	BRINC Drones is the sole source and exclusive provider of all the hardware, software, and support services related to the Drone as First Responder (DFR) program.
Callyo 2009 Corp.	Software used for surveillance purposes by the SWAT and Crisis Negotiations Team.	Callyo is the only police technology vendor offering a fully cloud-based mobile platform designed specifically for law enforcement. Its features include secure phone call recording, number masking, and real-time GPS tracking, which are essential for modern surveillance and public safety operations.
Centralsquare Technologies, LLC	Computer-aided dispatch and Record Management System, along with additional modules released within the Central Square system.	No other vendors can provide this licensing because it is specific to the CAD/RMS system offered by Centralsquare Technologies, LLC.
Corrections Technology Group (CTG)	Jail Cell Door/ Lock Repair, replacement parts, and service.	Corrections Technology Group (CTG) is located in Beaumont, CA, and is the only vendor in CA that meets our service and parts needs.

Emblems, Inc.	Emblems Authority is used for Uniform badges for Sworn and Professional Staff.	No other patch vendor has been able to provide or produce a vintage-style patch containing the specific color thread requested to coincide with our updated vintage-style badge.
Everbridge, Inc.	Nixle provides critical alerts and news to the community through SMS (text messages), email, the Web, or a mobile application.	The Nixle Engagement Communication System is exclusively available through Everbridge, Inc. Securing approval will enable the police department to acquire an annual subscription.
FileonQ, Inc.	Property and evidence management.	FileonQ is the only police vendor capable of providing this property and evidence record-keeping interface since FileonQ is exclusively proprietary, and it is the only vendor authorized to offer maintenance and support.
FARO Technologies, Inc.	The 3D Software Scanner utilized by the Traffic Services Bureau for the Major Accident Investigation Team (MAIT).	FARO is the only police vendor that provides 3D scanners capable of gathering millions of data points per scan, creating a realistic 3D map of the scanned area. This data can be translated into factual diagrams, crime scene analysis, 3D modeling, building or room plans, or tactical plans.
Flock Group, Inc.	Analyzes vehicle license plates.	Flock Safety is the only manufacturer and developer of a law enforcement-grade Automated License Plate

Forensic Nursing Specialist	Examinations and investigations utilized by the Detective Bureau.	The Detective Bureau collaborates with Pomona Valley Hospital Medical Center for sexual assault examination services. Law Enforcement Medical Services, Inc. The vendor is available 24 hours a day, 7 days a week, 365 days a year, in coordination with police operations.

V&V Manufacturing	Sworn and Professional Staff uniform badges.	V and V Manufacturing has produced Law Enforcement badges for over 40 years. They have developed a finish that no other badge manufacturing company can produce, consisting of an exclusive oxidizing antique bronze finish.

The above vendors and service providers for the Pomona Police Department are vital to meeting ongoing emergency service needs. Therefore, staff recommends, pursuant to Pomona City Code Section 2-994—Sole and Single Source Procurement: “A contract may be awarded as a sole or single source without competition upon review and verification and determined to be in the City’s best interest. Approval of the listed sole-source vendors is necessary to ensure compatibility and functionality for the Pomona Police Department.
