SUBJECT: APPROVAL OF AMENDMENT NO. 4 TO THE AGREEMENT FOR

ADMINISTRATIVE SERVICES WITH THE CALIFORNIA CHOICE

ENERGY AUTHORITY (CALCHOICE)

RECOMMENDATION:

It is recommended that the City Council take the following actions:

- 1) Approve Amendment No. 4 to the Agreement for Administrative Services (Amendment) with CalChoice (Attachment No. 1); and
- 2) Authorize the City Manager, or designee, to execute the Amendment and related documents with CalChoice, subject to approval by the City Attorney.

EXECUTIVE SUMMARY

The recommended actions will enable CalChoice to continue servicing Pomona Choice Energy with an updated fixed fee rate, formalized CPI adjustments, and clarifications of reimbursable expense, which now includes a new category for the CalChoice Board Secretary.

FISCAL IMPACT:

The execution of Amendment No. 4 will result in changes to the fixed fee and reimbursable expenses outlined in the Agreement. The revised rates in Exhibit C of the Agreement includes the

annual fixed fee costs of \$412,415 and encompasses annual estimated reimbursable expenses for data management services (\$768,000), professional services (\$367,625), and legal services (\$20,000).

The specific financial impacts are detailed in the new Exhibit C attached herewith in the Amendment and are available within the current fiscal year budget.

PREVIOUS RELATED ACTION:

The Agreement with the CalChoice has been amended on three previous occasions, most recently on August 16, 2023.

DISCUSSION:

The City's Community Choice Aggregation Program, Pomona Choice Energy (PCE), was established by the City Council on March 4, 2019. PCE has been successfully serving customers since 2020. The City executed an administrative services agreement (Agreement) with CalChoice, a Joint Powers Authority, on October 21, 2019. This Agreement outlines the services to be provided by CalChoice that support the PCE's operations.

Amendment No. 4 replaces Exhibit C to the Agreement. Key changes include an update to the fixed fee rate, formalizes CPI-related adjustments to professional services agreements and clarifies reimbursable expenses, inclusive of a new reimbursable expense category for the CalChoice Board Secretary position. Additionally, this Amendment also incorporates CalCCA Membership Fees into the fixed fee costs, which were previously paid separately outside of the Agreement.

Based on the foregoing, staff recommends that City Council approve Amendment No. 4 to the Agreement and authorize the City Manager, or her designees, to execute all contracts subject to the approval of the City Attorney.
