# **RECOMMENDATION:**

It is recommended that the City Council adopt the following resolution:

**RESOLUTION NO. 2025-65 – A RESOLUTION OF THE CITY** COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2024-25 CIP BUDGET BY INCREASING REVENUE ESTIMATES AND APPROPRIATIONS BY A TOTAL OF \$29,400: \$19.000 OF METROPOLITAN WATER DISTRICT **MEMBER** AGENCY ADMINISTERED PROGRAM FUNDING TO THE "HYDRATION STATIONS UPGRADES" PROJECT NUMBER 528-2590-XXXXX-71073, AND, \$10,400 FROM THE SOUTHERN CALIFORNIA GAS COMPANY TO THE "WATER RESOURCES BUILDING" PROJECT NUMBER 575-8125-XXXXX-93135; AND, UN-APPROPRIATE AND APPROPRIATE VARIOUS WATER AND SEWER CIP PROJECTS FUNDING AS DETAILED IN EXHIBIT A. PRIORITIZING EXPENDITURE OF VARIOUS AVAILABLE BOND PROCEEDS

# **EXECUTIVE SUMMARY**

The recommended actions will enable the receipt and appropriation of \$19,000 from Metropolitan Water District (MWD) Member Agency Administered Program (MAAP) funding into the "Hydration Stations Upgrades" project number 528-2590-XXXXX-71073 and \$10,400 in rent payment revenue from Southern California Gas Company (SoCalGas) into the "Water Resources Building" project number 575-8125-XXXX-93135. Additionally, the recommended action will utilize expenditure of available bond proceeds that are specific to water and sewer improvements in various Capital Improvement Program (CIP) projects, see Exhibit A to the Resolution (Attachment 2) for details.

# FISCAL IMPACT:

The fiscal impact of the proposed actions is to increase revenue estimates and appropriations by the total amount of \$29,400 in the Water Enterprise Fund (528-2590-40889-71073 and 575-8125-40190-93135). The total amount is a summation of \$19,000 from Metropolitan Water District (MWD) Member Agency Administered Program (MAAP) funding into the "Hydration Stations Upgrades" project number 528-2590-XXXXX-71073 and \$10,400 in rent payment revenue from Southern California Gas Company into the "Water Resources Building" project number 575-8125-XXXX-93135. Additionally, various Bond Proceeds are requested to be swapped for Water and Sewer Fund balance in order to prioritize the utilization of these funds. The fiscal impact is a net increase in the utilization of \$51,795 to the "Sewer Manhole Rehabilitation" project number 538-2590-XXXXX-86027. Details can be found in the following Table 3:

# **PREVIOUS RELATED ACTION:**

On June 3, 2024, City Council adopted Resolution No. 2024-85 to approve the FY 2024-25 CIP Budget which included all CIP projects listed in this report.

#### **DISCUSSION:**

The recommended action is necessary to receive and appropriate funds that are specific to the projects listed in Tables 1-3 above. Additionally, switching water and sewer funds with bond proceeds will allow the City to spend the remaining outstanding bond proceeds balances. Availability of these funds is a result of the projects being completed at a cost lower than originally projected. There is no change to the Funding Status of all the CIP projects found in the Table 1 and Table 2 above and in Exhibit A to Resolution No. 2025-65 (Attachment 1).
