BACKGROUND

The City of Pomona launched the Hamilton Park Art Call (Part A: Qualifications) on September 5th, 2024, seeking artists or artist teams artists or artist teams to submit qualifications to render, design and install artwork on several locations throughout Hamilton Park. The Commissioned artwork is intended to support Hamilton Park's \$2.5million renovation that occurred in 2023. This Call requires community engagement that invites the public to be a part of the process of artwork installation. (ie. Community art workshops) and that the community designs collected by the City are utilized in the final design of all artworks.

The City had specific eligibility requirements for all applicants to meet in order for the submission to be taken into consideration—

City of Pomona Development Services Department Cultural Arts Commission Meeting of October 28th, 2024 We are seeking an experienced Artist or Artist Team that reside within Los Angeles County or San Bernardino County. There will be a preference for Artists from and residing in Pomona, CA.

Artists will not be eligible to apply if they have been previously commissioned for a public artwork project by the City's Cultural Arts Commission in the last three years, whose budget was equal to, or exceeds, \$100,000. Artists who currently have contracts with the City will need to complete all projects before the deadline of Part A: Submission of Qualifications takes place to be considered.

This Call for Art closed on October 3, 2024, by 5PM PST. There was a total of 16 submissions, and of those 16 submissions only 14 met the eligibility requirements.
