

RESOLUTION NO. 2024-148

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE CITYWIDE SALARY SCHEDULE FOR FISCAL YEAR 2024-25 TO MEET THE CALIFORNIA CODE OF REGULATIONS TITLE 2, SECTIONS 570.5 AND 571 TO IMPLEMENT A FOUR PERCENT (4%) SALARY INCREASE TO FULL AND PART-TIME CLASSIFICATIONS

WHEREAS, the City Council has the authority to create, classify and design salary scales/ranges for all City of Pomona employee positions;

WHEREAS, California Code of Regulations (CCR) Title 2, Section 570.5 and amendment to CCR Section 571 requires a consolidated Salary Schedule that is publically available showing all City classifications and salary ranges;

WHEREAS, the City Council wishes to meet the requirements of these regulations by adopting a Salary Schedule, which sets forth the salary scales/ranges for all City of Pomona employee classifications;

WHEREAS, the City Council desires to amend the Fiscal Year 2024-25 Salary Schedule adopted by City Council Resolution Number 2024-89;

WHEREAS, in 2023 the City Council adopted memorandum of understandings with all labor and unrepresented groups, which included annual salary increases to all classifications.

WHEREAS, “Exhibit A” includes the Citywide Salary Schedule that reflects the negotiated four percent (4%) increase to salaries and classifications under the Pomona Police Officers’ and Police Management Association, Pomona Mid-Management Confidential Employees, Pomona City Employees’ Chapter of the Teamsters Local 1932, and Part-Time General Unit Teamsters Local 1932 Memorandum of Understandings and for Executive Management Group A and B Employees, Mid-Management Library Group C-2 Employees, and Part-Time Management/Confidential Compensation Plans effective as of October 1, 2024.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council hereby adopts the Citywide Salary Schedule for all City of Pomona employee classifications as set forth in the attached “Exhibit A” to reflect a negotiated four percent (4%) salary increase effective October 1, 2024.

SECTION 2. The action approved herein shall become effective October 1, 2024.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its adoption.
