# FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT

This FIRST AMENDMENT to the Professional Services Agreement ("AGREEMENT") for the professional landscaping consulting services ("FIRST AMENDMENT") is hereby entered into on this 1st day of October 2025 by and between the City of Pomona (the "CITY") and Conserv Construction, Inc. (the "CONSULTANT"), hereinafter referred to collectively as "PARTIES."

## RECITALS

WHEREAS, on February 24, 2025, the City Council approved a Professional Services Agreement with CONSULTANT for the Residential Landscape Evaluation and Sprinkler Tune-up or Smart Controller Project, in the amount of One Hundred Fifty Thousand Dollars (\$150,000); and

WHEREAS, the CITY and CONSULTANT executed said Agreement, which is attached hereto (Attachment 1) and incorporated herein by this reference; and

WHEREAS, the City previously received \$50,000 in reimbursable grant funding for the Project from the Metropolitan Water District, via Three Valleys Municipal Water District, which was applied toward partial funding of the AGREEMENT, and

WHEREAS, the City has subsequently received an additional \$70,000 in reimbursable grant funding for the Project from the Metropolitan Water District, via Three Valleys Municipal Water District; and

WHEREAS, the Parties now wish to enter this FIRST AMENDMENT to allocate the additional \$70,000 in grant funds toward the Project and increase the total compensation to \$220,000; and

NOW, THEREFORE, the Parties hereby agree as follows:

#### AMENDMENT

- Incorporation of Recitals. The recitals listed above are true and correct and, are hereby incorporated herein by this reference.
- 2. Amendment to Section 3.3.1 of the Agreement. Section 3.3.1 is hereby amended in its entirety to read as follows:
  - "3.3.1. Compensation. Consultant shall receive compensation, including authorized reimbursements, for all Services rendered under this Agreement at the rates set forth in Exhibit "C-1" attached hereto and incorporated herein by reference. The total compensation shall not exceed Two Hundred Twenty Thousand Dollars (\$220,000.00) without written approval of the City Council or City Manager as applicable. Extra Work may be authorized, as described below, and if authorized, will be compensated at the rates and manner set forth in this Agreement."
- 3. Changes to Exhibits. Exhibit "C" to the AGREEMENT, is hereby replaced in its entirety with Exhibit "C-1" attached herewith and incorporated herein by this reference.

The total contract amount for the Project shall not exceed \$220,000.00.

Payments shall be made per site and shall depend on the services provided as outlined in the pricing sheet.

Total costs shall encompass all expenses related to installation and repairs, including prevailing wage labor, administration, equipment, transportation, overhead, profit, insurance, taxes, fees, incidentals, and any other relevant costs essential for the provision of the required services.

Upon completion of on-site evaluation, customer will be presented with the appropriate service option for their site. Upgrades shall be limited to 10-stations. Tune-up services shall be completed during upgrade appointment.

Upgrades include a 6-month warranty for installation, and a two-to-four-year manufacturer warranty, depending on manufacturer. All tune-up repairs include a 90-day warranty for equipment installed during the tune up.

In the event that this Agreement is renewed pursuant to Section 3.1.2, the rates set forth above may be increased or reduced each year at the time of renewal, but any increase shall not exceed the Consumer Price Index, All Urban Consumers, Los Angeles-Long Beach-Anaheim, California.

- **4. No other Changes.** Except as amended by this FIRST AMENDMENT, all provisions of the AGREEMENT shall remain in full force and effect, and shall govern the actions of the Parties under this AGREEMENT.
- 5. Counterparts. A manually signed copy of this FIRST AMENDMENT, which is transmitted by facsimile, email, or other means of electronic transmission, shall be deemed to have the same legal effect as delivery of an original executed copy of this FIRST AMENDMENT for all purposes.
- **6. Severability**. If any part of this FIRST AMENDMENT is held to be unlawful or void, all other parts of this FIRST AMENDMENT shall remain effective.
