RECOMMENDATION:

It is recommended that the City Council adopt the following resolution:

RESOLUTION NO. 2024-92 – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING THE FY 2023-24 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY UN-APPROPRIATING FUNDS IN THE AMOUNT OF \$1,317,658, CLOSING THREE (3) CIP PROJECTS, AND APPROPRIATING \$400,000 OF UNEXPENDED FUNDS

EXECUTIVE SUMMARY:

Adoption of Resolution 2024-92, Attachment 1, will result in unappropriating Water, Sewer, and Measure W funds from four CIP projects, thereby releasing those funds back to the original funding sources or to fund balance, closing the three CIP projects, and appropriating funds to one CIP project.

FISCAL IMPACT:

The un-appropriation of funds in four CIP projects will release a total of \$1,317,658; where the total funds released from three closed projects equals \$917,658 and \$400,000 of Safe Clean Water Program (Measure W) funds will be re-appropriated from a fourth CIP project. Funding from these four CIP projects includes various bond proceeds, Water fund, Sewer fund, and Measure W proceeds; all returning to their respective fund balances. Measure W proceeds will then be appropriated to the "Landscape Improvements – Various Locations" project.

See Table 1 and Table 2 below for CIP project-specific details. Table 1 provides the detail for projects to be closed, Table 2 provides details of the projects to have Measure W funds unappropriated and appropriated.

Amendment of the FY 2023-24 Capital Improvement Program (CIP) Budget Page 3 of 3 – June 17, 2024

PREVIOUS RELATED ACTION:

On June 5, 2023, City Council adopted Resolution No. 2023-98 adopting the City's FY 2023-24 Capital Improvement Program budget which included all CIP projects listed in Tables 1 and 2 above.

DISCUSSION:

The three CIP projects detailed in Table 1 are ready to be closed with the remaining funds returning to the original source or their respective fund balance. The "Recycled Water – Infrastructure Rehabilitation" project is no longer needed and is being closed. The "Water Main Replacements – Design" project was completed at a cost lower than originally estimated. The "Sewer Pipeline Condition Assessment" project was also completed under budget, and the remaining funding may be returned to the fund balance.

Additionally, Measure W funds are no longer needed in the "Multi-Benefit Stormwater Optimization and Infrastructure" project and can be released to fund the "Landscape Improvements – Various Locations" project. This project will provide for the design and construction of landscape improvements within small areas of various parks, City-owned lots, and medians that include drought-tolerant landscaping while providing benefits of the Safe Clean Water objectives and goals.
