# Youth Who Talked With Prisoner Pays \$20 Fine

Ted Floyd Reeves, 18, of 1173 W. Phillips Blvd., was sentenced to pay a \$50 fine or serve a 25-day term in jail, but \$30 of the fine or 15 days of the jail term was suspended, after he pleaded guilty yesterday in municipal court to a charge of unlawful communication with a prisoner.

Reeves paid the \$20 balance of the fine and was placed on a year of summary condition providing he does not violate any law, minor traffic laws excepted.

Reeves was arrested at 4:50 p. m. Tuesday in the driveway at the police station where he was caught conversing with Jack Alan Lloyd, 24, of 582 E. Kingsley Ave., who was standing in front of a second floor jail window, after Reeves had appeared after visiting hours and had been refused permission to see Lloyd, police reported.

# Youth Accused In Rape Case

Teddy Floyd Reeves, 18, of 1173 W. Phillips Blvd., was arraigned today in municipal court and held in lieu of \$2,500 bail for preliminary hearing on March 24 on a charge of statutory rape.

Complaint in the case was filed by the mother of a 15-year-old Pomona girl. Juvenile investigators arrested the youth last Monday night.



# Youth Certified To Juvenile Court

Case of Ted Floyd Reeves of 1173 W. Phillips Blvd., accused of a statutory rape offense involving a 15-year-old Pomona girl, was transferred to juvenile court yesterday when Reeves appeared in municipal court for preliminary hearing.

Reeves was certified to juvenile court, still unable to post \$2,500 bail, on motion of his attorney, Maurice O'Connor, on grounds that Reeves reached the age of 18 only last August.

Complaint in the case was filed last week by the girl's mother.
