MAYOR/COUNCILMEMBER COMMUNICATIONS

Councilmember Martin thanked the community members that attended the District 1 Area Commander meeting, and thanked Pomona PD staff for hosting it.

Councilmember Lustro discussed an email from the County Assessor's office regarding property assessments.

Councilmember Ontiveros-Cole expressed thanks to the Public Works Department for the work completed on E. Holt Ave, attended a tribute to Ron VanderMolen and shared kind word about him.

Councilmember Preciado expressed condolences for Ron VanderMolen and for Omar Fernando Meza. Councilmember Preciado thanked City Manager Scott and Pomona PD Chief Ellis for addressing and discussing roadblocks. Councilmember Preciado attended the summer concert in downtown Pomona and announced future concert events. Councilmember Preciado also announced upcoming summer events hosted by Community Services. Lastly, Councilmember Preciado discussed his recommendation to resume the Activate Pomona program used during the pandemic.

Councilmember Garcia invited folks to attend the upcoming National Night Out event, wished everyone a safe school year and encouraged neighbors to support each other. Councilmember Garcia expressed support for Councilmember Preciado's recommendation to resume the Activate Pomona program.
