**RESOLUTION NO. 2025-06 – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, AMENDING APPENDIX B OF THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF POMONA AND THE POMONA MID-MANAGEMENT/CONFIDENTIAL EMPLOYEES ASSOCIATION (PMMCEA) TO ADJUST THE SALARY SCALE OF THE PAYROLL SUPERVISOR**

**WHEREAS**, the City Council has the authority to create, classify and assign salary scales/ranges for all City of Pomona classifications;

**WHEREAS**, on November 6, 2023 the City Council adopted Resolution No. 2023-218 adopting the 2023-2027 Memorandum of Understanding (MOU) between the City of Pomona and the Pomona Mid-Management/Confidential Employees’ Association (PMMCEA), which also established a Roster of PMMCEA Classifications; and

**WHEREAS**, in order to meet department staffing needs, the City Council desires to amend Appendix B of the aforementioned MOU by the actions provided herein.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Pomona as follows:

**SECTION 1.** That the City Council hereby authorizes an amendment to Appendix B of the PMMCEA MOU by adjusting the salary scale of the classification indicated below:

**SECTION 2.** That any portion of previously adopted resolutions concerning salaries inconsistent with this Resolution shall be deemed repealed.

**SECTION 3.** The action approved herein shall become effective January 12, 2025.

**SECTION 4.** The City Clerk shall attest and certify to the passage and adoption of this resolution and it shall become effective immediately upon its adoption.
