

RESOLUTION NO. 2026-65

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, TO AMEND THE FY 2025-26 CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET BY CREATING A NEW CIP PROJECT, “CITY HALL BOILER REPLACEMENT,” FD428 CIP PROJECT FUND | CC2590 CIP | WORKTAG: PRJ-00015 AND APPROPRIATING \$120,000 OF AVAILABLE GENERAL FUND RESERVES TO THE PROJECT

WHEREAS, the City Council desires to create a new Capital Improvement Program (CIP) Project, “City Hall Boiler Replacement,” FD428 CIP Project Fund | CC2590 CIP | Worktag: PRJ-00015;

WHEREAS, the City Council desires to provide funding for the replacement of the existing failing boiler system at Pomona City Hall due to aging equipment and challenges sourcing obsolete parts to maintain reliable building operations and heating functionality at the facility; and

WHEREAS, the City Council desires to amend the FY 2025-26 CIP Budget by appropriating \$120,000 of available General Fund Reserves to CIP “City Hall Boiler Replacement,” FD428 CIP Project Fund | CC2590 CIP | Worktag: PRJ-00015.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. The City Council amends the FY 2025-26 CIP Budget by creating a new CIP Project, “City Hall Boiler Replacement,” FD428 CIP Project Fund | CC2590 CIP | Worktag: PRJ-00015.

SECTION 2. The City Council amends the FY 2025-26 CIP Budget by appropriating \$120,000 of available General Fund Reserves (FD101 General Fund | CC2590 CIP | SC263 Transfer to CIP | to “City Hall Boiler Replacement,” FD428 CIP Fund | CC2590 CIP | RC116 Transfer from General Fund | Worktag: PRJ-00015.

SECTION 3. The City Clerk shall attest and certify to the passage and adoption of this Resolution, and it shall become effective immediately upon its approval.
