A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, APPROVING THE MAXIMUM ALLOWABLE TOW AND STORAGE RATE SCHEDULE FOR CITY-INITIATED TOWS

WHEREAS, the City Council is vested with the authority to approve the rates charged by nonexclusive franchise towing companies for City-initiated tows under section 58-676 (21) of the Pomona City Code;

WHEREAS, the City currently has franchise agreements with towing companies to provide towing services for City-initiated tows; and

WHEREAS, all four franchise towing companies submitted requests to the Chief of Police to increase the towing and storage rates for City-initiated tows;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. This resolution shall supersede all rates established by City Council Resolution No. 2019-181.

SECTION 2. The City Council hereby establishes the maximum allowable tow and storage rate schedule for City-initiated tows as follows:

Effective Date 11/20/23 (Section 4)

Category	Tows	Inside Storage	Outside Storage
Class A (Cars and Trucks)	\$281.00/ hour	\$73.00/ day	\$70.00/ day
Class B (Over 1-ton w/out Air Brakes)	\$339.00/ hour	\$76.00/ day	\$74.00/ day
Class C (2-3 Axle w/ Air Brakes)	\$490.00/ hour	\$78.00/ day	\$78.00/ day
Class D (Tractor Trailers)	\$540.00/ hour	\$80.00/ day	\$80.00/ day
Motorcycles	\$281.00/ hour	\$73.00/ day	\$70.00/ day

SECTION 3. The City Council hereby establishes that the maximum allowable rate for "After Hours/ Weekend Release" for City-initiated tows shall be \$100.00. For the purposes of this section, "After Hours" shall mean those hours of any weekday that the franchisee is not open to the public. For purposes of this section, "Weekend Release" shall mean holidays during which the franchisee is not regularly open for business, Saturdays (except such time between the hours of 8 a.m. and 12 p.m.), or Sundays.
