SUBJECT: AWARD CONSTRUCTION CONTRACT TO ONYX PAVING COMPANY, INC. IN THE AMOUNT OF \$3,682,000 FOR “STREET PRESERVATION LOCAL – CITYWIDE (FY 24-25),” PROJECT NO. 428-2590-XXXXX-68593

RECOMMENDATION:

It is recommended that the City Council take the following actions:

- 1) Award a construction contract to the lowest responsive bid from Onyx Paving Company, Inc. for “Street Preservation Local – Citywide (FY 24-25),” Project No. 428-2590-XXXXX-68593, to include all of Base Bid (A&B) items, plus Additive Alternate item No. 1 in the total amount of \$3,682,000;
- 2) Find that the project referenced above is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301(c) and that the proposed project will not have a significant effect on the environment; and
- 3) Authorize the City Manager, or designee, to execute the construction contract and any subsequent change orders on behalf of the City of Pomona (City).

EXECUTIVE SUMMARY:

Approval of the recommended actions will result in awarding a Public Works Construction Contract to Onyx Paving Company, Inc. in the total amount of \$3,682,000 to include the Base Bid items and Additive Alternate item 1, for “Street Preservation Local – Citywide (FY 24-25),” Project No. 428-2590-XXXXX-68593.

This project was adopted with the Capital Improvement Program (CIP) Fiscal Year 2024-2025 Budget. Approval of this action will award a construction contract in the amount of \$3,682,000. The following table details the fiscal impacts associated with the recommended actions:

PUBLIC NOTICING REQUIREMENTS:

In accordance with Section 2-1003 - Formal Procedure of the City’s Purchasing Ordinance, a Notice of Inviting Bids for construction for “Street Preservation Local – Citywide (FY 24-25),” Project No. 428-2590-XXXXX-68593 was posted on the City’s electronic bidding platform, Planet Bids, on March 26, 2025. The Invitation for Bids was also posted to the Inland Valley Daily Bulletin on April 28, 2025.

ENVIRONMENTAL IMPACT:

The Project is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301(c), in that it meets the guidelines for the implementation of CEQA because the project consists of the operation, repair and maintenance of existing facilities.

DISCUSSION:

On March 26, 2025, the City issued an Invitation for Bids (IFB) No. 2025-10 “Street Preservation Local – Citywide (FY 24-25),” Project No. 428-2590-XXXXX-68593 via the City’s electronic bidding platform, Planet Bids. The solicitation was disseminated to 645 potential bidders, with 46 of them downloading the IFB, resulting in the City receiving four (4) proposals. Bids were due on May 14, 2025, and were thoroughly reviewed. Onyx Paving Company, Inc., is the lowest qualified bidder.

As outlined in the bid documents and per City Code 2-1003 (1) (g), the lowest bidder is evaluated based on the overall bid amount, base bid, and all additive alternates. The bid results are reflected in the table. The actual award is based on funding availability. The proposed contract award to Onyx Paving, based on available funding, is as follows:

Base Bid	\$3,337,000
Additive Alternative 1	<u>\$ 345,000</u>
Contract Award Amount	\$3,682,000

The location map is included in Attachment 2. Anticipated construction will begin late July 2025 and take approximately 100 working days, potentially being completed by late November, 2025 if favorable weather conditions allow. Work will consist of a combination of slurry seal and grind and overlay depending on location and level of need.
